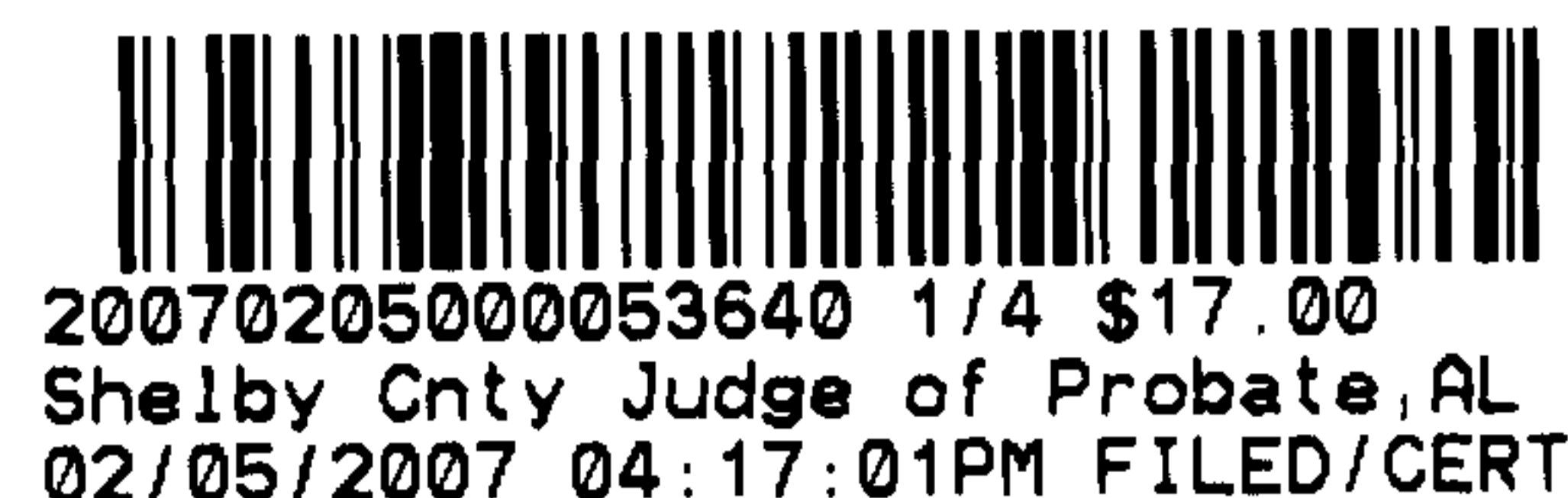

**SPECIFIC DURABLE POWER OF ATTORNEY**

**act and deed, to do and to execute, or to concur with persons jointly interested**

**with myself therein in the doing or executing of, all or any of the following acts,**

**deeds, and executing of, all or any of the following acts, deeds, and things necessary to accomplish the following:**

**1. 

**GIVING AND GRANTING unto said attorney-in-fact full**


