KNOW ALL MEN BY THESE PRESENTS, That, I, JAMES KENNETH BEAN, of the county of Shelby, State of Alabama, have made, constituted and appointed, and by these presents do make, constitute and appoint MARK A. BEAN (my son) as my true and lawful attorney for me and in my name, place and stead, and for the use and benefit, to perform the following specific duties:

The continuing, absolute and discretionary power to deal with any property, real or personal, as freely and completely as I might in handling my own affairs. Such powers shall include but are not limited to the following:

- 1. To acquire, recover, sell, exchange, mortgage, lease or dispose of any or all property, real or personal, at public or private sale, at such time and price and upon such terms and conditions as he shall determine.
- To borrow money upon such terms and conditions as he may determine and the power to expend money upon such terms and conditions as he may determine.
- To employ accountants, attorneys and such other agents as he may deem advisable, and to pay reasonable compensations for their services.
- 4. To collect my debts, to pursue claims against others whom I have a claim against, to endorse my checks, to execute my government vouchers, to deposit my money and to gather and secure my real property or other personal property.
- 5. To prepare and file my tax returns and to represent me in tax matters and/or to hire other professionals such as certified public accountants and attorneys to represent me in tax matters.
- 6. To transfer title to my automobiles.
- To compromise, defend, settle or adjust any claim against me. It is my desire and I direct that, MARK A. BEAN exercise the powers and authority herein granted independently and without prior or subsequent order or approval of any court or judicial authority. I direct that he shall not be required to give bond for the performance of his duties as such, or to file an inventory
- 8. To act as the guardian over my person and/or to act as the conservator over my estate. It is my desire and I direct that **MARK A. BEAN**, exercise the powers and authority herein granted independently and without prior or subsequent order or approval of any court or judicial authority. I direct that he shall not be required to give bond for the performance of his duties as such, or to file an inventory.
- To perform any act which I may do myself, including but not limited to the power to purchase or sell securities, the power to open accounts with securities brokers or dealers, the power to vote stocks, the power to do my banking, the power to enter any safe deposit boxes that are in my name, the power to borrow money, the power to sign, execute, deliver, or endorse or guarantee promissory notes in my name and to pledge or mortgage as security for those loans real and/or

personal property owned by me, the power to subject any real property that I own to any options, easements, servitudes, covenants, restrictions, leases, licenses.

- 10. The power to bind me to contracts.
- The power to foreclose on any mortgages on real and/or personal property and to take title to the property in my name.
- The power to place insurance on any of my real and/or personal property owned by me and to make and execute bonds of all kinds, either as principal or surety.
- 13. The power to make gifts.
- 14. The power to form corporations, companies, and partnerships.
- 15. The power to conduct business in my name.
- 16. The power to purchase, acquire, sell United States Treasury bonds.
- 17. The power to create, execute, and transfer into trust.
- 18. The power to receive my United States mail, certified mail, or other correspondence delivered or handled by a courier.

If court proceedings are commenced after the execution of this power of attorney to appoint a guardian, conservator, or other fiduciary to take charge of my person or to manage and conserve any of my property, I nominate and appoint my attorney as my guardian, conservator, or other such fiduciary, who will serve without bond unless otherwise required by a court of competent jurisdiction.

That in the event that MARK A. BEAN is not capable of and/or willing to serve as my true and lawful attorney for me and in my name, place and stead and for my use and benefit I hereby constitute and appoint Donna M. Willis (my daughter) of 8233 Wynwood Drive, Helena, Alabama 35180 to be my alternative true and lawful attorney for me and in my name, place and stead and for my use and benefit and possessing the same powers as enumerated above but not to be limited to those enumerated powers as above.


That I, JAMES KENNETH BEAN desire that this General Durable Power of Attorney shall be effective immediately upon the recording of same.

A copy of this power of attorney shall have the same full force and effect as though it were an original.

The enumeration of specific powers herein is not intended to, nor is it intended to limit or restrict the powers of my attorney.


