FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 31st day of March, 2004, Charlie H. Summerlin, a single man and Megan K. Janssen, a single woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20040406000176640, said mortgage having subsequently been transferred and assigned to Bank of New York, as Trustee for the Certificate Holders of CWALT 2004-16CB; and
