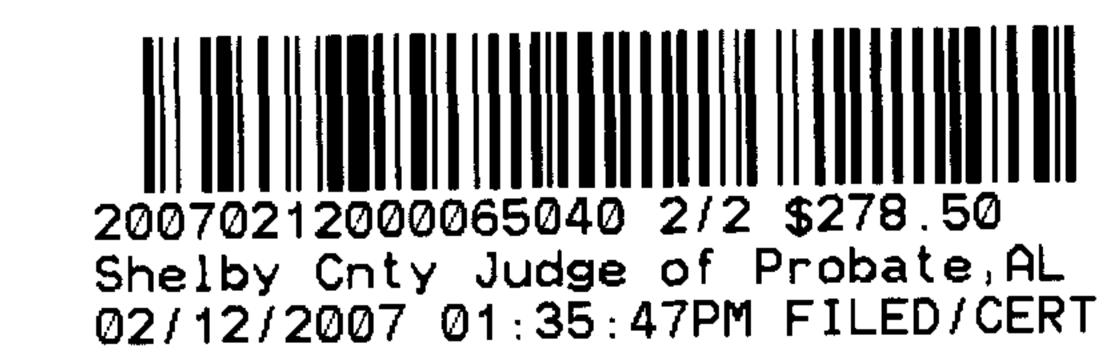
WHEREAS, the Grantors desire through this conveyance to transfer the real property described herein into the sole name of the Grantee.

HELTON**, their interest in and to the following described real estate, situated in Shelby County, Alabama, to-wit:
