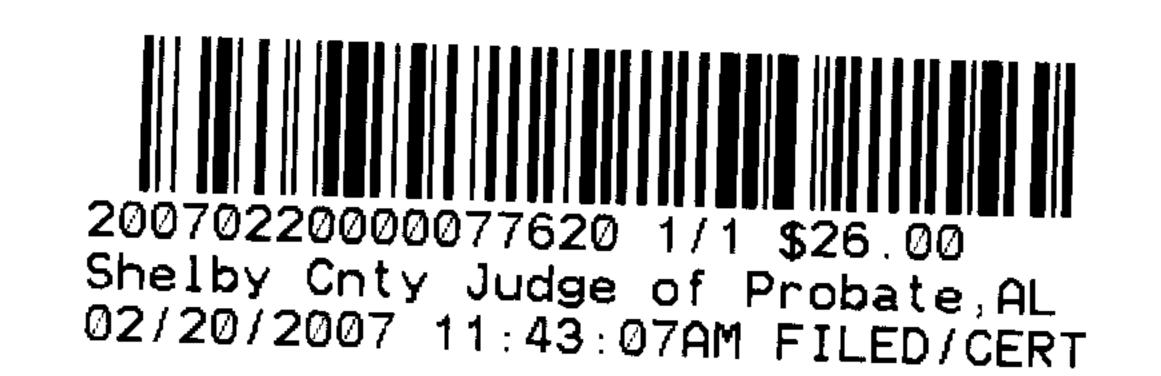

KNOW ALL MEN BY THESE PRESENTS, That in consideration FIFTEEN THOUSAND AND NO/00 (\$15,000.00), and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, I or we,

FRED WAYNE HORTON and wife, MYRA GAYLE HORTON

(herein referred to as Grantor) grant, bargain, sell and convey unto,

C. D. HONEYCUTT and wife, FRANCES HONEYCUTT

(herein referred to as Grantees), the following described real estate, situated in: SHELBY County, Alabama, to-wit:

Commence at the SW corner of the SW¼ of the NW¼ of Section 6, Township 22 South, Range 1 West; thence run N 88 degrees 32 minutes 12 seconds E along the South line thereof for 760.96 feet; thence N 22 degrees 05 minutes 37 seconds E for 1261.84 feet to the POINT OF BEGINNING; thence continue last described course for 1124.02 feet to the Southwesterly R/W of Alabama Power Co. easement; thence S 61 degrees 47 minutes 44 seconds E run along said R/W for 390.08 feet; thence S 41 degrees 48 minutes 24 seconds W for 1149.89 feet to the POINT OF BEGINNING.
