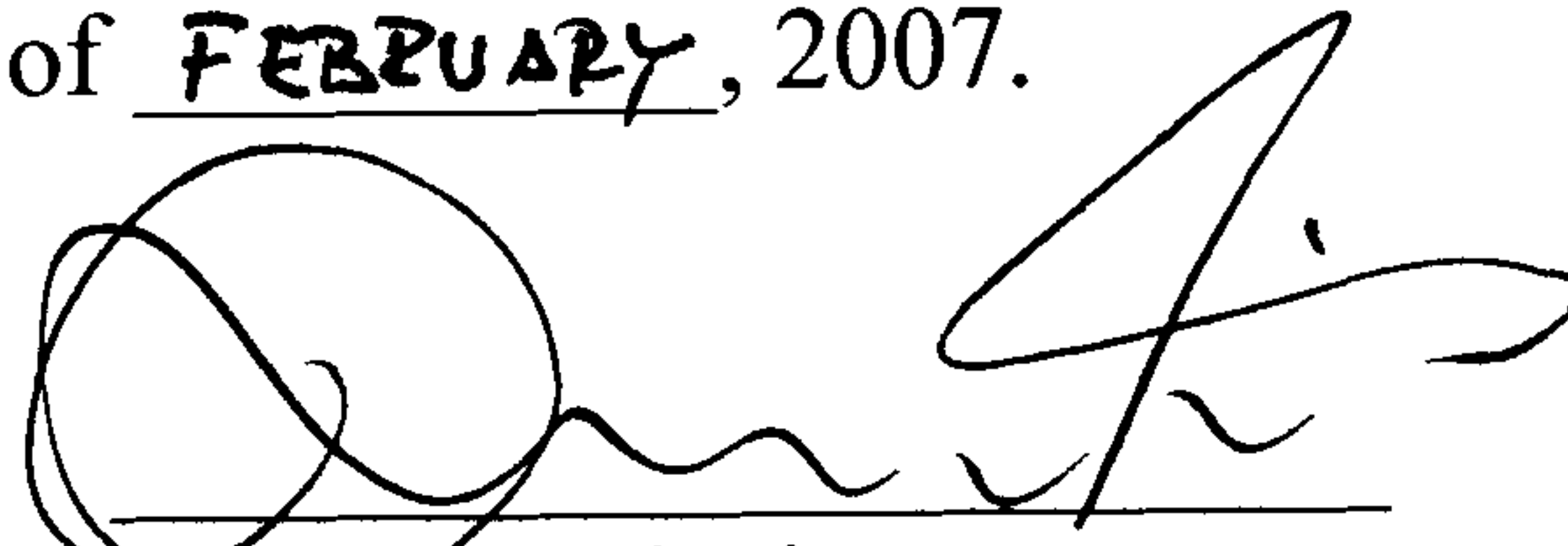
1. The name of the corporation is William's Drywall & Painting, L.L.C.
2. The period of its duration is perpetual.
3. The corporation shall be governed by the "Alabama Business Corporation Act" Code of Alabama (1975) Section 10-2A-1 et seq., including all amendments thereto; and all other laws of Alabama governing or applicable to corporations. The corporation shall enjoy the powers and privileges and be subject to the duties, restrictions and liabilities of other corporations, except where inconsistent with the provisions and purposes of the aforesaid "Alabama Business Corporation Act" of Alabama. The powers of the corporation pursuant, to the laws of the State of Alabama, include the power to contract in its own name, to take, hold, and sell real and personal property in its own name, independent of its members and shareholders, to lend and borrow money and to sue and be sued as an independent entity.
4. The purpose or purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Alabama Business Corporation Act, including, but not limited to providing drywall and painting services.
5. The aggregate number of shares of capital stock which the corporation shall have authority to issue is one thousand (1,000) shares of common stock, par value one dollar (\$1.00) per share.
6. The location and mailing address of the initial registered office of the corporation is 109 Heather Lane, Pelham, Alabama 35124, and the name of its registered agent at such address is William Palacios.
7. The number of directors constituting the initial board of directors of the corporation is two, and the names and addresses of the persons who are to serve as directors until the first annual meeting if shareholders and until their successors are elected and shall qualify are as follows:

8. The name and address of the incorporator of the corporation is William Palacios, 109 Heather Lane, Pelham, Alabama 35124.
9. Each shareholder shall have a pre-emptive right to purchase shares of any class of capital stock of the corporation, including treasury stock.
10. The corporation shall have the right to purchase, take, receive or otherwise acquire, hold, own, pledge and transfer or otherwise dispose of its own shares. Purchases by the corporation of its own shares, whether direct or indirect, may be made to the extent of unreserved and unrestricted earned surplus and capital surplus of the corporation available therefore.
11. The corporation shall have such by-laws as may be adopted by the shareholders. The power to alter, amend or repeal such by-laws shall be vested in the shareholders. Such by-laws may provide that any action required to be taken at a meeting of shareholders may be taken without a meeting if a consent, in writing, setting forth the action to be taken shall be signed by all the shareholders entitled to vote with respect to the subject matter thereof. Such consent shall have the same force and effect as a unanimous vote. The by-laws may further provide that whenever any notice is required to be given under either the laws of the State of Alabama, this Certificate of Incorporation, or by the by-laws adopted pursuant to the provisions hereof, a waiver in writing signed by the person or person entitled to such notice, whether before or after the time stated herein, shall be equivalent to the giving of such notice.

IN WITNESS WHEREOF, the undersigned, acting as incorporator of the corporation named herein in accordance with the Alabama Business Corporation Act, executes these Articles of Incorporation this 21st day of FEBRUARY, 2007.
