\$152,500.00 was paid from first mortgage recorded herewith.



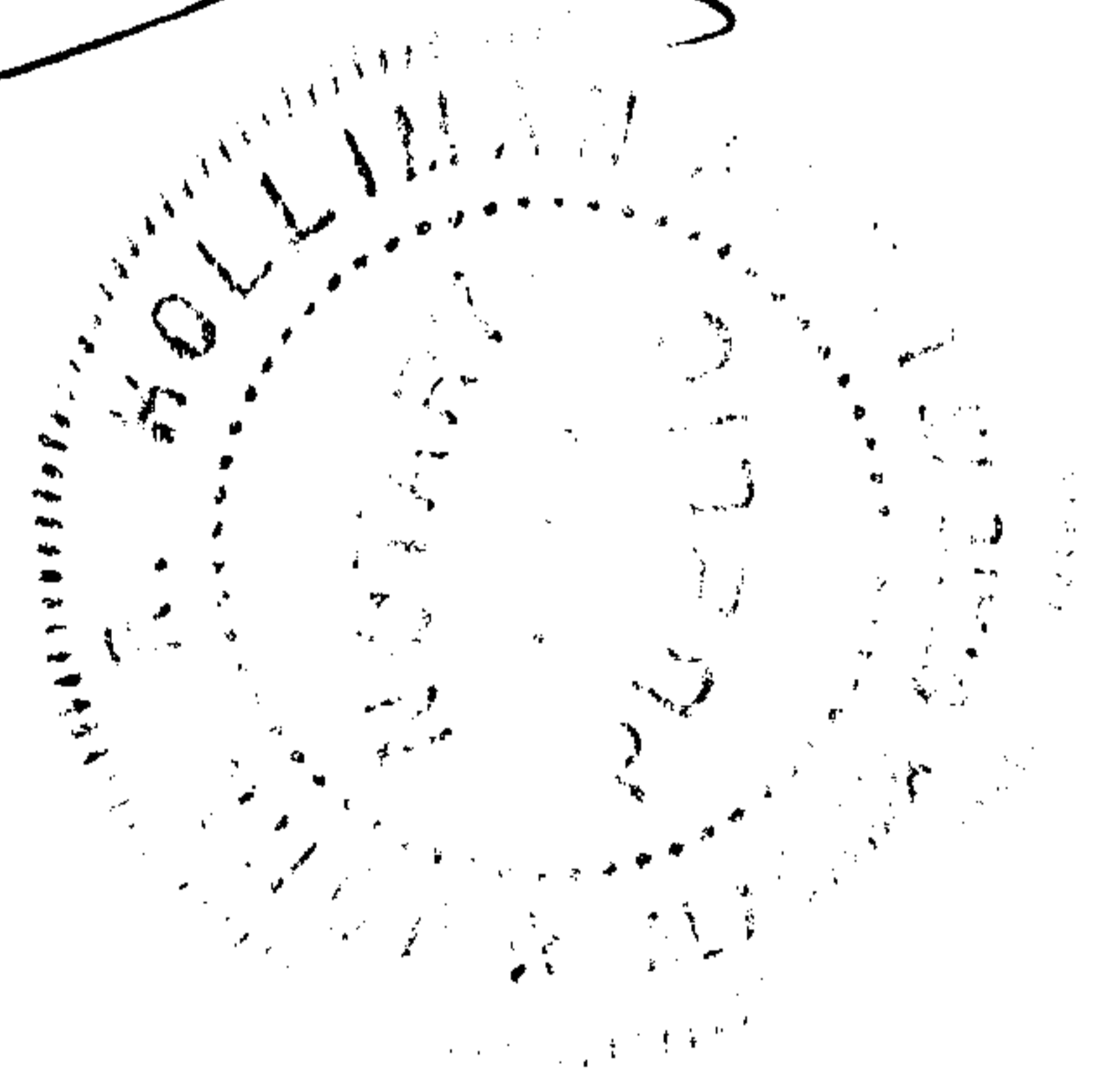
