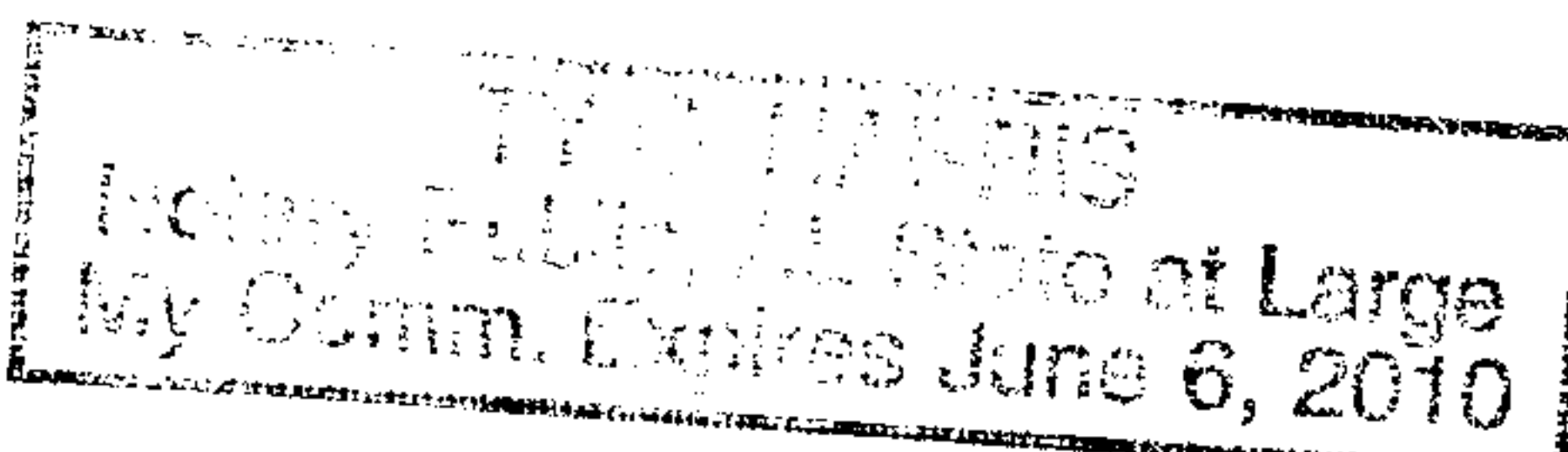
## OATH OF OFFICE
