POWER OF ATTORNEY

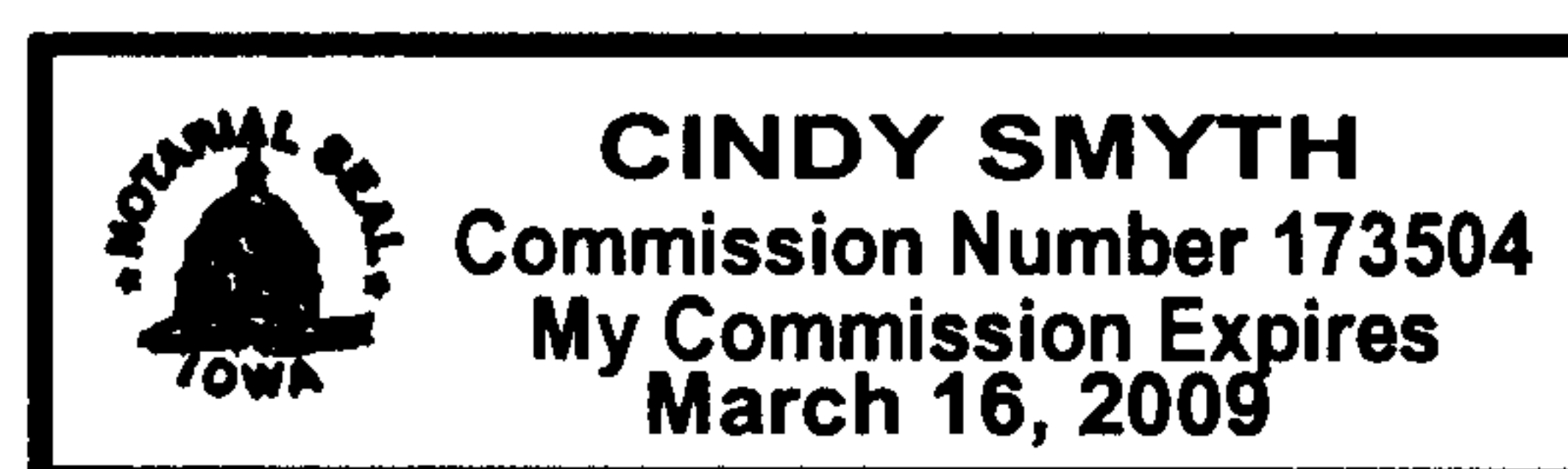

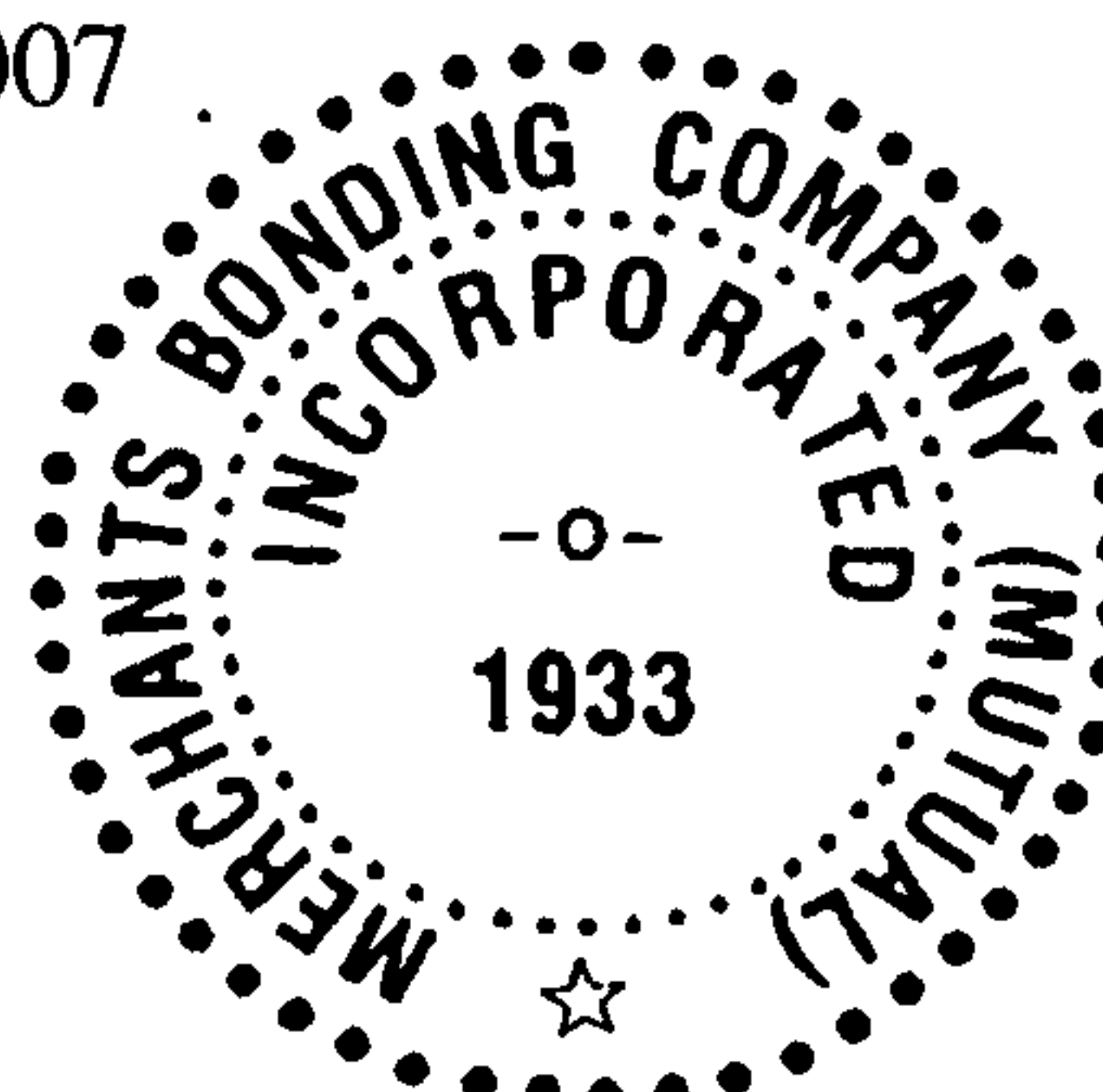
