KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 15th day of April, 2004, Elwanda Clark, a single woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20040428000219150, said mortgage having subsequently been transferred and assigned to CitiMortgage, Inc. successor in interest by merger to CitiFinancial Mortgage Company Inc. ; and

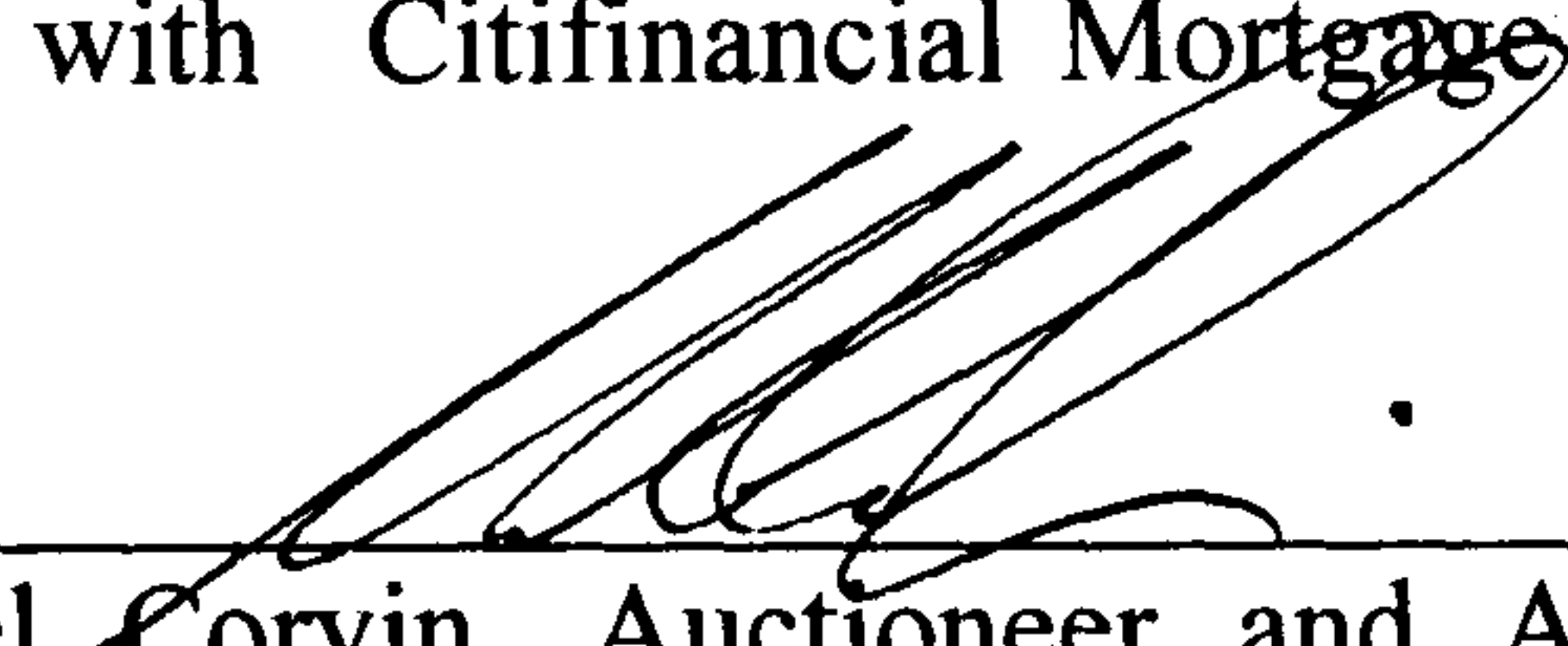

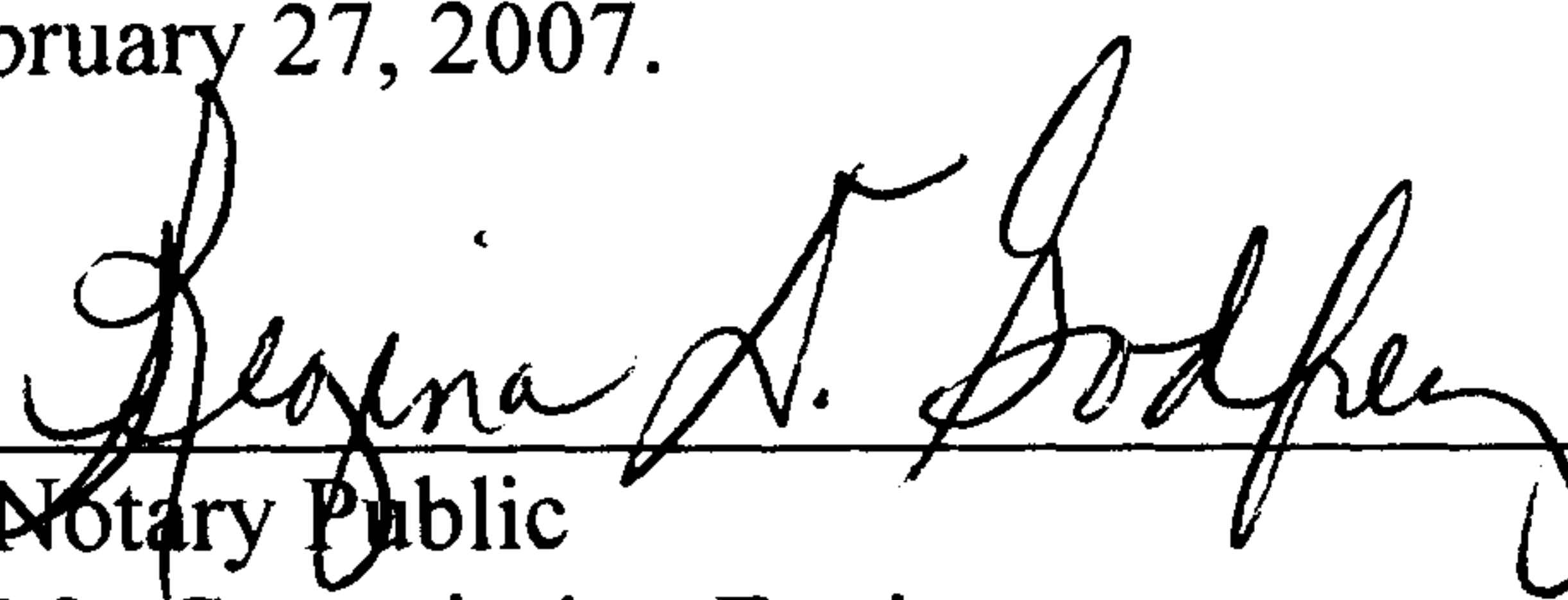
