

# **ARTICLES OF ORGANIZATION OF COAR CONSTRUCTION, LLC**

The undersigned hereby adopt the following Limited Liability Company Articles of Organization:

## **ARTICLE I**

### **NAME**

The name of the limited liability company is Coar Construction, LLC.

## **ARTICLE II**

### **DURATION**

The period of duration is perpetual.

## **ARTICLE III**

### **PURPOSES**

The Limited Liability Company has been organized for the following purposes:

1. To engage in the business of building or assembly of any infrastructure on a site or sites; and
2. The transaction of any or all lawful business which may be incidental or beneficial to the company.

## **ARTICLE IV**

### **OFFICE & REGISTERED AGENT**

## **ARTICLE IX**


### **OTHER PROVISIONS**
