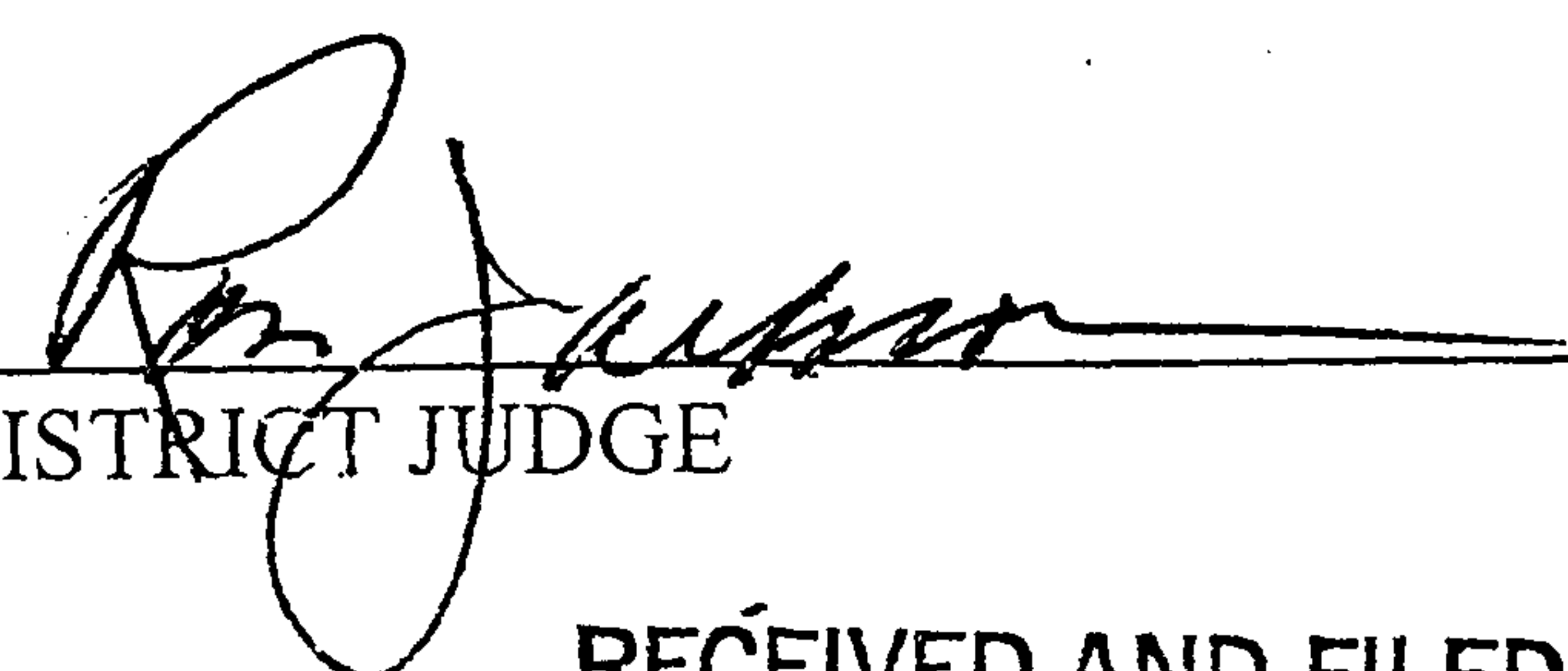

ORDER

Pursuant to Rule 55(b)(2) of the Alabama Rules of Civil Procedure, this action came on the motion of the Plaintiff for a default judgment filed with an accompanying affidavit, and the Clerk's records showing service on the Defendant on August 18, 2006, and the Defendant having been duly served with the summons and complaint, and his default having been duly noted, IT IS ORDERED AND ADJUDGED that the Plaintiff recover of the Defendant the sum of \$800.00 and costs of court.
