DOMESTIC FOR-PROFIT CORPORATION ARTICLES OF INCORPORATION GUIDELINES

THE UNDERSIGNED, in order to form a corporation under and pursuant to the Alabama Business Corporation Act, does hereby certify as follows:

Article I: The name of the Corporation is Terrain Irrigation, Inc.

Article II: The registered office of the Corporation is at 4168 Crossings Ln., Birmingham, AL 35242, and its registered agent at such address is Christopher Clay Jones.

Article III: The purpose of the Corporation is to engage in any lawful act or activity for which corporations may be organized under the Alabama Business Corporation Act.

Article IV: The total number of shares of stock which the Corporation is authorized to issue is one thousand (1000) shares of Common Stock, with no par value, all of which shall be of the same class. Each holder thereof shall be entitled to one vote at all meetings of stockholders for each share of such stock standing in his name on the books of the Corporation on the record date fixed for such meeting.

Article V: The name and mailing address of the Incorporator is Christopher Clay Jones, 4168 Crossings Ln., Birmingham, AL 35242.

Article VI: A director of the Corporation shall not be personally liable to the Corporation or its stockholders for monetary damages for breach of fiduciary duty as a director, except as otherwise provided by the Alabama Business Corporation Act as the same exists or may hereafter be amended.

Article VII: The stockholders, or the Board of Directors of the Corporation without the assent or vote of the stockholders, shall have the power to adopt, alter, amend or repeal the By-Laws of the Corporation.

Article VIII: The Corporation reserves the right to amend, alter, change or repeal any provision set forth in this Certificate of Incorporation in the manner now or hereafter prescribed by law.
