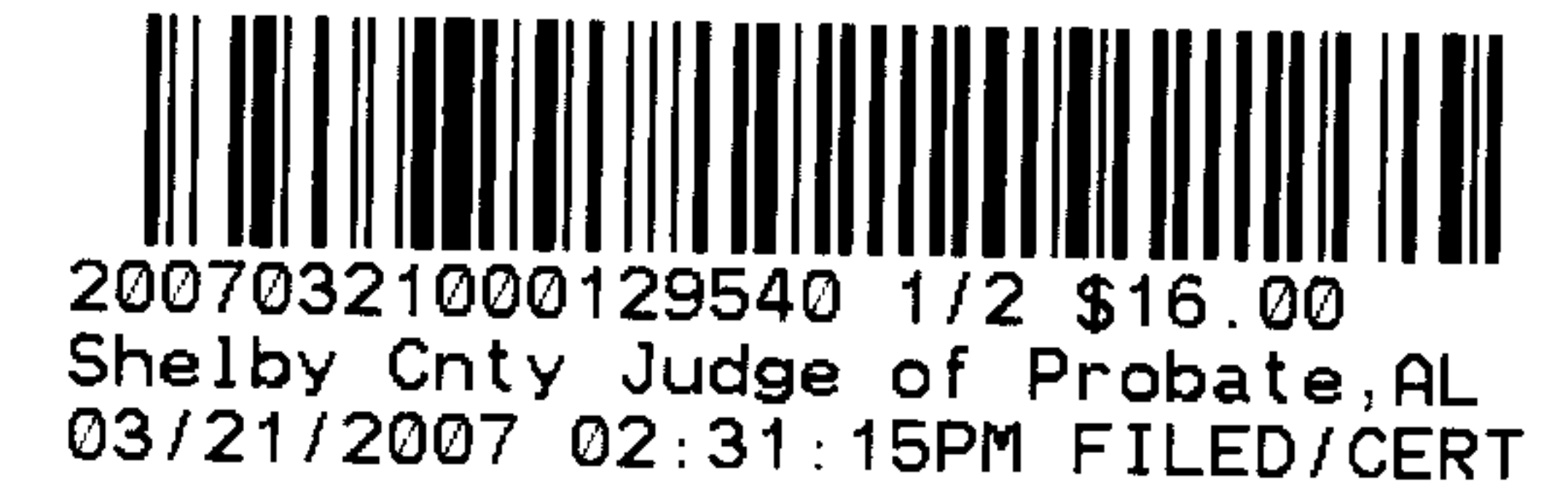

MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on October 13, 2005, **Derrick Morrison and Kimberly Morrison aka Kimberly C Morrison, husband and wife, Party of the First Part**, executed a certain mortgage to **Mortgage Electronic Registration Systems, Inc., acting solely as nominee for EquiFirst Corporation, its successors and assigns**, which said mortgage is recorded in Instrument No. 20051027000560190, in the Office of the Judge of Probate of Shelby County, Alabama Which said Mortgage was last sold, assigned and transferred to US Bank, N.A. as Trustee; and

WHEREAS, default in the payment of the indebtedness secured by said mortgage, and US Bank, N.A. as Trustee did declare all of the indebtedness secured by the said mortgage due and payable and said mortgage subject to foreclosure as therein provided and did give due and proper notice of the foreclosure of said mortgage, in accordance with the terms thereof, by publication in the Shelby County Reporter, a newspaper of general circulation in Shelby County, Alabama, in its issues of 2/7/07, 2/14/07, 2/21/07; and

WHEREAS, on March 1, 2007, the day on which the foreclosure sale was due to be held under the terms of said notice, during the legal hours of sale, said foreclosure was duly and properly conducted and the person conducting the sale on behalf of the mortgagee did offer for sale and sell a public outcry, in front of the main entrance of the Courthouse, Shelby County, Alabama, the property hereinafter described; and

WHEREAS, the highest and best bid obtained for the property described in the aforementioned mortgage was the bid of US Bank, N.A. as Trustee in the amount of **ONE HUNDRED FIVE THOUSAND FIVE HUNDRED SIX AND 29/100 DOLLARS (\$ 105,506.29)**; which the person conducting the sale on behalf of the mortgagee offered to credit on the indebtedness secured by said mortgage, and said property was thereupon sold to US Bank, N.A. as Trustee; and
