

PARTIAL RELEASE OF MORTGAGE

KNOW ALL PERSONS BY THESE PRESENTS that Bank of York, the owner and holder of that certain mortgage dated June 30, 2003, executed by Sean Simmons and Ann W. Begin at a ½ inch rebar found locally accepted to be the Northeast corner of the Northeast ¼ of the Southeast ¼ of said Section 23; thence run in a Southerly direction along the East line of said quarter-quarter Section for a distance of 816.41 feet to a ½ inch rebar found; thence turn an angle to the right of 00 degrees 00 minutes 40 seconds and run in a Southerly direction along said east line for a distance of 484.20 feet to a ½ inch rebar found locally accepted to be the Southeast corner of the northeast 1/4 of the Southeast ¼ of said Section 23; thence turn an angle to the right of 90 degrees 55 minutes 21 seconds and run in a Westerly direction along the South line of said quarter-quarter Section for a distance of 334.68 feet to an iron pit set; thence turn an angle to the right of 89 degrees 04 minutes 14 seconds and run in a Northerly direction for a distance of 1,302.96 feet to an iron pin set on the North line of said Northeast 1/4; thence turn an angle to the right of 91 degrees, 19 minutes 52 seconds and run in an Easterly direction along said North line for a distance of 334.73 feet to the point of beginning; said parcel of land containing 10.0 acres, more or less.

This release shall not impair the lien of the said mortgage as to the lands therein described but not hereby released.
