 - A. The foregoing disclaimer is irrevocable and unqualified.
 - B. The foregoing disclaimer is made to the Administratrix of the Decedent's Estate within nine (9) months after the creation of the disclaimed interests.
 - C. The Undersigned has not accepted the interests disclaimed hereby or any of their benefits.
 - D. The interests hereby disclaimed pass without any direction on the part of the Undersigned, and the interests pass to a person or persons other than the Undersigned.
 - E. The Undersigned will execute any other instruments that may be required to effectuate this disclaimer.
