I. William A. Cole (the "Decedent") died on the 21<sup>st</sup> day of November, 2003. There was no valid Last Will and Testament of the Decedent offered for probate, and, accordingly, the Decedent died intestate and his estate is due to be distributed in accordance with the intestacy laws of the State of Alabama. Prior to the execution of this disclaimer, the Decedent's only surviving issue, Keri Dianne Cole Calloway, executed a disclaimer of her entire interest in the Decedent's estate.

This disclaimer is intended to be, and shall be interpreted in all respects as, a qualified disclaimer under Section 2518 of the Internal Revenue Code of 1986, as amended, and the rules and regulations thereunder. Pursuant to the provisions of that Code Section and of Sections 43-8-290 - 298 of the Code of Alabama (1975), as amended, the Undersigned represents that:

- A. The foregoing disclaimer is irrevocable and unqualified.
- B. The foregoing disclaimer is made to the Administratrix of the Decedent's Estate within nine (9) months after the creation of the disclaimed interests.
- C. The Undersigned has not accepted the interests disclaimed hereby or any of their benefits.
- D. The interests hereby disclaimed pass without any direction on the part of the Undersigned, and the interests pass to a person or persons other than the Undersigned.
