IN THE MATTER OF THE ESTATE OF WILLIAM ARMOUR COLE, DECEASED;
SHEILA WHITTINGTON COLE, PERSONAL REPRESENTATIVE:

This cause coming on to be heard on the petition for final settlement in the above entitled cause, and it appearing from said petition that the petition has been executed by the Personal Representative of the estate, and it further appearing that Sheila Whittington Cole is the sole beneficiary of the estate of William Armour Cole, deceased, and that the said Sheila Whittington Cole has filed in this cause, in writing, her statement as said beneficiary that she has been notified of the filing of said petition and that she has accepted service of said notice and that the acceptance has been filed in this cause and that she waives further notice of the hearing; that said petition has been properly acknowledged by the Personal Representative in this cause and that the said beneficiary is over the age of 19 years.

It further appearing to the Court that more than six months have expired since the appointment of said Personal Representative and that all claims filed in said cause have been paid.

It also appearing to the Court that the Personal Representative has marshalled all the assets of the estate and that after the payment of all charges against the estate that there

is now on hand for distribution all of the assets subject to distribution.

It further appearing to the Court that John Hollis Jackson, Jr., has completed his legal services in connection with the administration of said estate and that he is entitled to a reasonable attorney's fee of \$ 600.00 for his services in said matter and the Court has determined that said attorney's fee is due to be awarded to him for his services in said cause.

It also appearing to the Court that the court costs incidental to the administration of said estate due and payable to the Judge of Probate of Chilton County, Alabama, is \$ 31.50, due from said estate funds.

It further appearing to the Court that the Personal Representative has marshalled the assets of said estate and has conducted the said estate in accordance with the statutes and laws thereto appertaining and that she is entitled to a commission for her services, as provided by law, but that she has waived any right to a commission for said services.

It finally appearing to the Court that the sole distributee of said estate, Sheila Whittington Cole, is due to have all of the assets of said estate which are subject to distribution made over to her.

It is, therefore, ORDERED, ADJUDGED and DECREED by this Court as follows: That Sheila Whittington Cole, as Personal Representative of said estate, be and she is hereby directed to forthwith disburse the property now held by her as Personal Representative to the persons due to receive said property and that she deliver to the payees checks made payable to the payees as follows: First, to Robert M. Martin, Judge of Probate, any court costs presently due and payable; second, to John Hollis Jackson, Jr., as attorney for said estate, a

reasonable fee for his services rendered in said cause; third, to Sheila Whittington Cole, the balance then left on hand of said estate in its entirety.

Upon the final disbursement of the funds as herein directed, then the Personal Representative be and she is hereby fully and finally discharged and relieved from the office of Personal Representative and the sureties on the Personal Representative's Bond filed herein are fully discharged.
