

**ARTICLES OF INCORPORATION
OF

Pursuant to the provisions of the Alabama Business Corporation Act, the undersigned hereby adopts the following Articles of Incorporation.

Article 1.

The name of the corporation is NAIL VIP, INC.

Article 2.

The duration of the corporation is perpetual, unless otherwise stated.

Article 3.

The purpose of this corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of Alabama. The general purposes for which the corporation is organized are:

1. To engage in the business of nail care.
2. To engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.
3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

Article 4.

The corporation is authorized to issue only one class of shares of stock which shall be designated common stock. The total number of shares it is authorized to issue is 1,500 shares, each with a par value of \$1.00 per share.
