ARTICLES OF ORGANIZATION

The undersigned, a natural person over the age of eighteen (18) years, acting as Organizer of a limited liability company under the Alabama Limited Liability Company Act, Sections 10-12-2 through 10-12-55 of the Code of Alabama of 1975, does hereby adopt the following Articles of Organization for such limited liability company.

ARTICLE ONE NAME




ARTICLE NINE
