FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 22nd day of September, 2005, Elizabeth A Vinson, an unmarried woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as a nominee for Countrywide Home Loans, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument # 20051118000601860, said mortgage having subsequently been transferred and assigned to Bank of New York as Trustee for the Certificate Holders CWABS, Inc. The following described real property situate in the City of Pelham, County of Shelby, and State of Alabama, to wit: Unit "C", Lot 2, of Chandalar South Townhouse, as recorded in Map Book 7, Page 166 A&B in the Office of the Judge of Probate of Shelby County, Alabama, and more particularly described as follows: Commence at the most Easterly corner of said Lot 2; thence in a Northwesterly direction along the NE line of said Lot 2 for a distance of 65.37 feet; thence 90 Degrees left in a Southwesterly direction for distance of 20.20 feet to the Point of Beginning; said point being further identified as being the Point of Intersection of the center line of the wood fence enclosing the fronts of Units "A", "B", "C" and "D", and the center line of the wood fence common to Units "B" and "C"; thence continue in a Southwesterly direction along the center line of fence, party wall, and fence, common to Units "B" and "C" a distance of 68.51 feet to the intersection of the fence enclosing the backs of Units "A", "B", "C" and "D"; thence right in Northwesterly along the center line of last described wood fence for a distance of 20.85 feet to the intersection with a wood fence common to Units "C" and "D"; thence right in a Northeasterly direction along the center line of fence, party wall and fence common to units "C" and "D", a distance of 68.67 feet to the intersection with the center line of the fence enclosing the fronts of Units "A", "B" and "C" and "D"; thence right in a Southeasterly direction along the center line of last described fence a distance of 20.59 feet to the Point of Beginning. 
