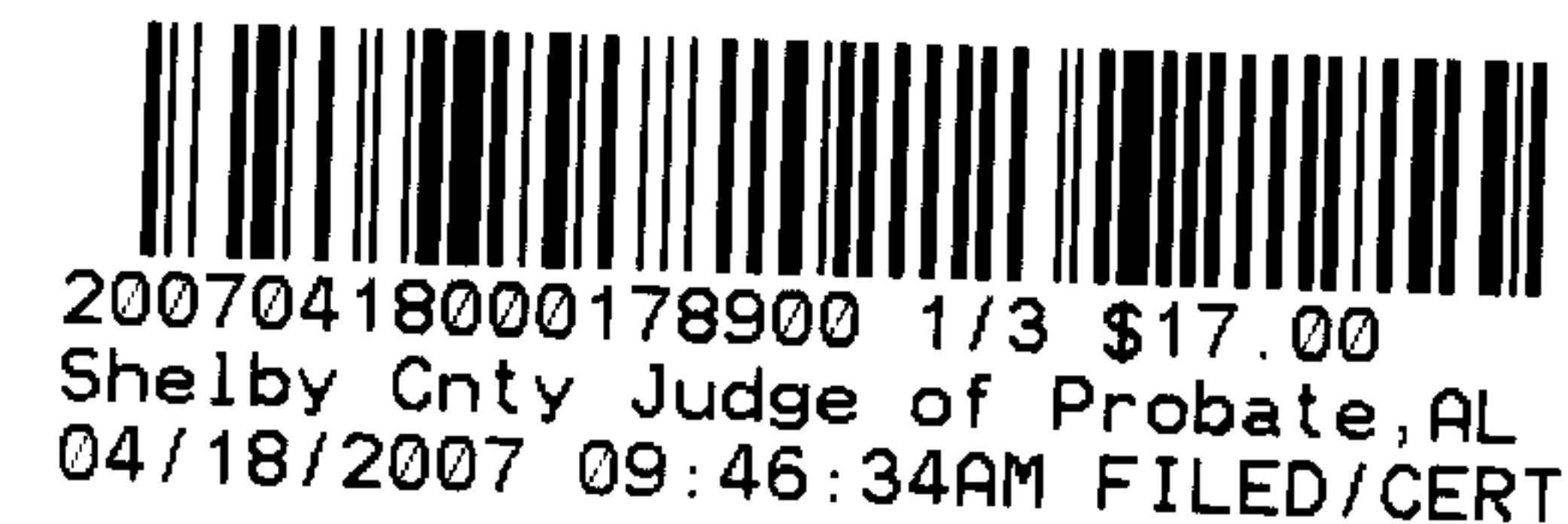


JOINT MOTION TO DISMISS PLAINTIFF'S LIEN CLAIMS ONLY
