KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on March 29, 1996, **Glenda D. Taylor, a single individual, Party of the First Part**, executed a certain mortgage to **South States Mortgage Corporation**, which said mortgage is recorded in Instrument No. 1996-10418, in the Office of the Judge of Probate of Shelby County, Alabama Which said Mortgage was last sold, assigned and transferred to NationsBanc Mortgage Corporation in Book 1996, Page 10419 and recorded on April 1, 1996

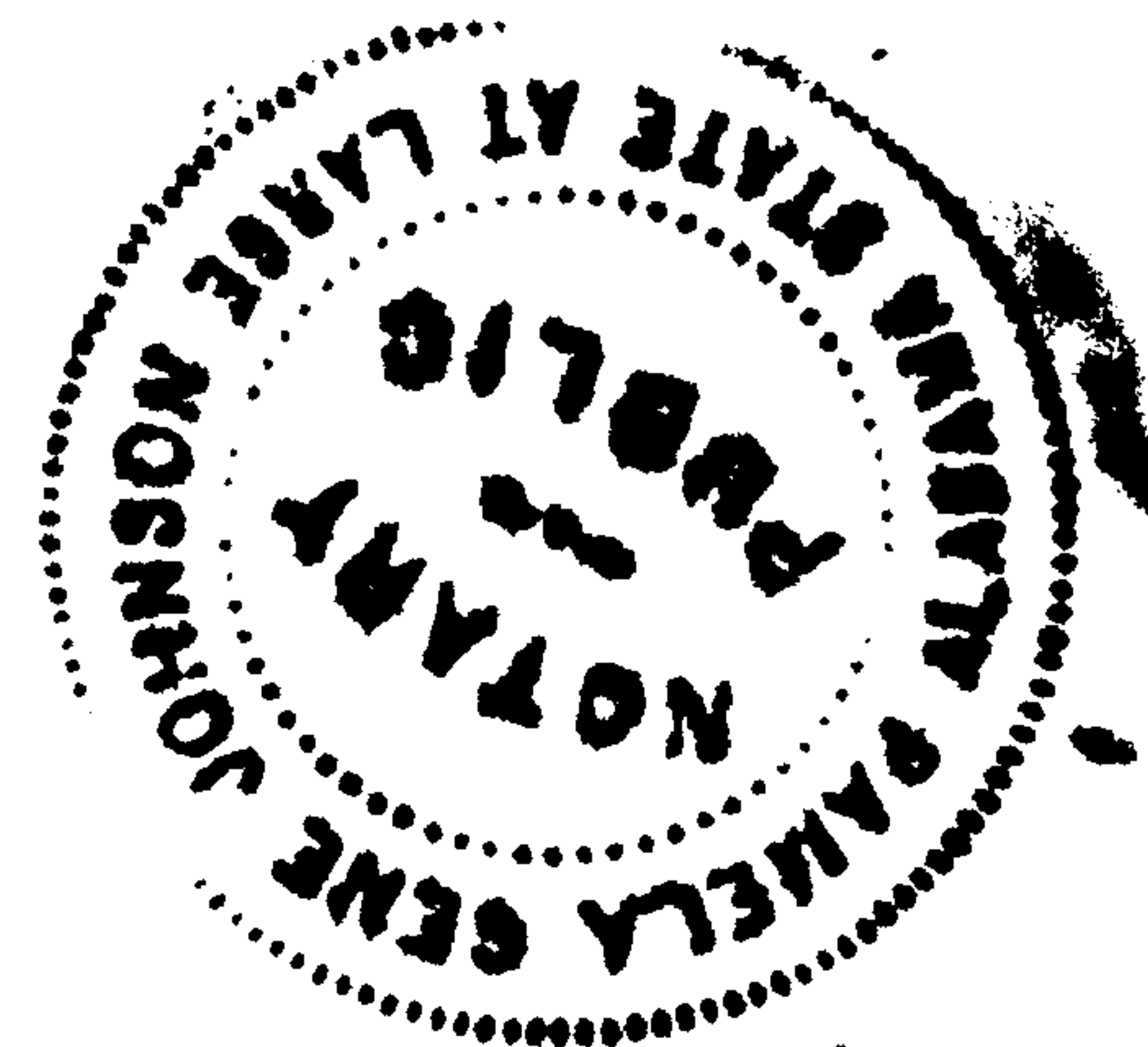
