

CERTIFICATE OF APPOINTMENT'AND AUTHORITY



Pursuant to the authority vested in me by Delegations of Authorities Certificate, Section VII, <u>Legal</u>, I hereby appoint **LETA WILSON** as Assistant Treasurer of the Federal Home Loan Mortgage Corporation (Freddie Mac) for the sole purpose of executing the documents regarding real properties which are foreclosed or real property acquired by other means and assigned to **Homesteps** for disposition, including, but not limited to, the following:
