KNOW ALL MEN BY THESE PRESENTS: That, in consideration of Eighty-Seven Thousand Three Hundred Dollars (\$87,300.00) and other good and valuable consideration to him in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, SECRETARY OF HOUSING AND URBAN DEVELOPMENT (herein referred to as "Grantor") does by these presents grant, bargain, sell and convey unto ELROY MACKEY AND JESSICA MACKEY (herein referred to as "Grantees") for and during their joint lives and, upon the death of either of them, then to the survivor, in fee simple, and to the heirs and assigns of such survivor forever, together with every contingent remainder and right of reversion, the following described real estate situated in Pelham, Shelby County, Alabama, to-wit:

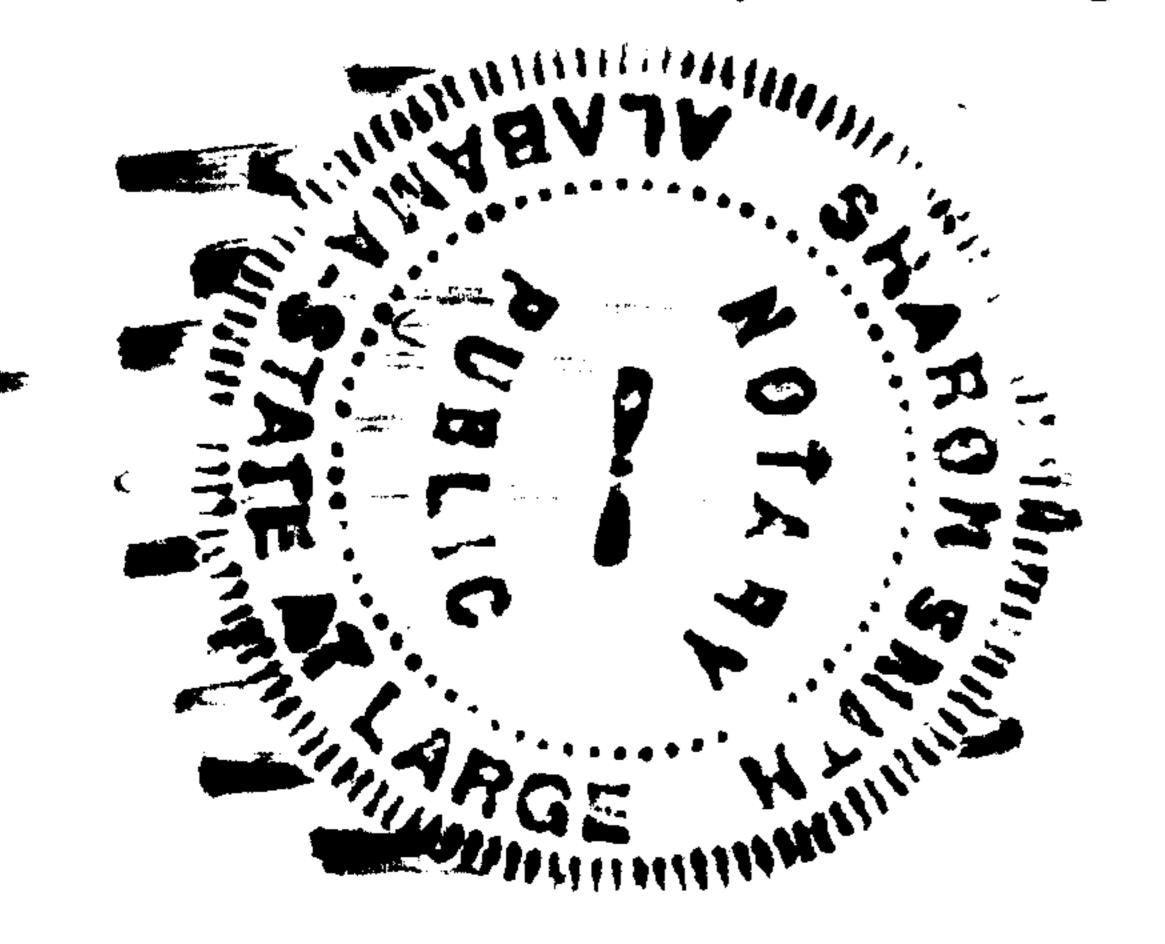
