



Begin at the intersection of the East line of County Highway 105 and the North line of the Southwest ¼ of the Northwest ¼ of the Northwest ¼, Section 13, Township 20 South, Range 3 West, thence East on said North line to the Northwest line of Montevallo-Ashville Road; thence Southwesterly on the road right of way to the intersection of the East right of way County Highway 105; thence Northerly on said highway right of way 260 feet to the point of beginning, more particularly described as follows: Commence at the intersection of the East line of County Highway 105 and the North line of the Southwest ¼ of the Northwest ¼ of the Northwest ¼, Section 13, Township 20 South, Range 3 West, Huntsville Meridian; run thence East on said North line for 188.41 feet to the apparent Northwest line of the Montevallo-Ashville Road; run thence South 34 deg. 27 min. 06 sec. West along said line for 356.12 feet to the intersection of the East right of way of Shelby County Highway 105; run thence in a Northeasterly direction along said right of way of County Road 105 along a curve to the left having a chord bearing North 02 deg. 32 min. 44 sec. East and a chord distance of 293.95 feet and an arc distance of 294.69 feet to the point of beginning.
