
"DURABLE/GENERAL"

I, <u>Kenneth Peirce Doe</u>, do assign my twin brother, <u>Jeffrey Franklin Doe</u>, as my Power of Attorney. This Power of Attorney is to become effective immediately upon signature and Notary, with a one (1) year expiration date. This "Durable& General" Power of Attorney is to remain in effect in the event that I ever become disabled, incapacitated or incompetent (through medical or legal results).

As a servicemember in the United States Army, this durable/general POA is to remain in effect in the case that I ever become a Prisoner of War (POW/MIA) or am ever declared Missing in Action. This POA is to stay in effect for the entire duration in the event that I am also deployed or mobilized that might be up to or longer than 18 months.

This POA is to be used for the purposes listed below:

- 1. Taxes, in which I am a legal resident of the State of Alabama.
- 2. All claims and financial transactions to include:
 - a. Cash Checks, collect social security and / or unemployment or disability
 - b. File Claims / receive payments
 - c. Start / stop allotments or change the amount
 - d. Receive military/civilian "leave & earning statements" (LES) or W-2's
 - e. Start / stop direct deposits
 - f. Obtain Service Relief Loan and VA Home Loan
 - g. Workman's compensation and medical claims or issues
 - h. Veterans Affairs and military & civilian retirement or benefits
- 3. Household goods/personal property
- 4. Real Property/land:
 - a. Buy/mortgage
 - b. Refinance/sell
 - c. Manage/lease/rent house or property
- 5. Vehicles:
 - a. Possess, use, register, etc.
 - b. Sell/buy
 - c. Ship/receive
- 6. Child Care:
 - a. Medical/legal
 - b. Custody/care
 - c. Loco Parentis
 - d. Education enrollment

2005 Last Will & Testament and 2005 Durable Power of Attorney, 2006 Last W & T and 2006 POA
