As additional security for the indebtedness secured by the Mortgage and Security Agreement, Mortgagor grants, bargains, sells and conveys unto Mortgagee the following described parcel of real property and subjects the same to the demise of the Mortgage and Security Agreement: TO HAVE AND TO HOLD the same and every part thereof unto Mortgagee, its successors and assigns forever.
