STATUTORY WARRANTY DEED

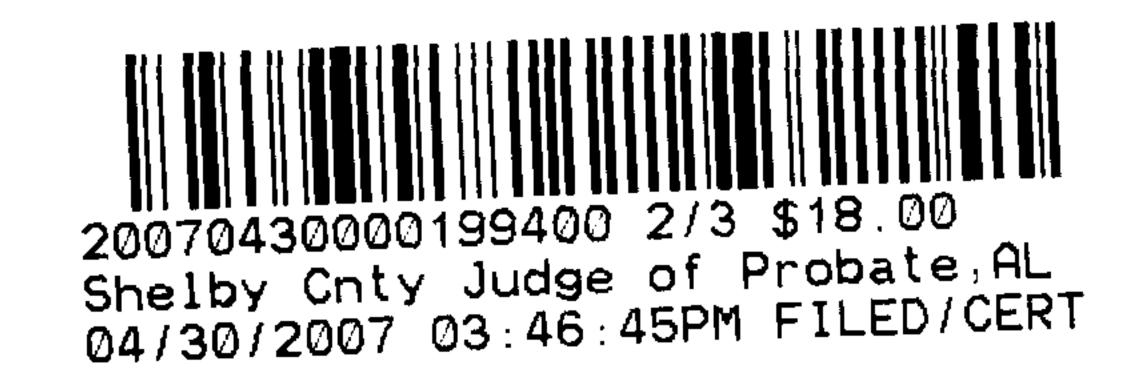
Know All Men by These Presents: That in consideration of ONE MILLION THREE HUNDRED FIFTY THOUSAND DOLLARS 00/100 (\$1,350,000.00) DOLLARS to the undersigned grantor, RIVERWOODS PROPERTIES, LLC, in hand paid by the GRANTEES herein, the receipt of which is hereby acknowledged, the said GRANTOR, does by these presents, grant, bargain, sell and convey unto NSH CORP., (herein referred to as GRANTEES, the following described real estate, situated in Shelby County, Alabama, to-wit:

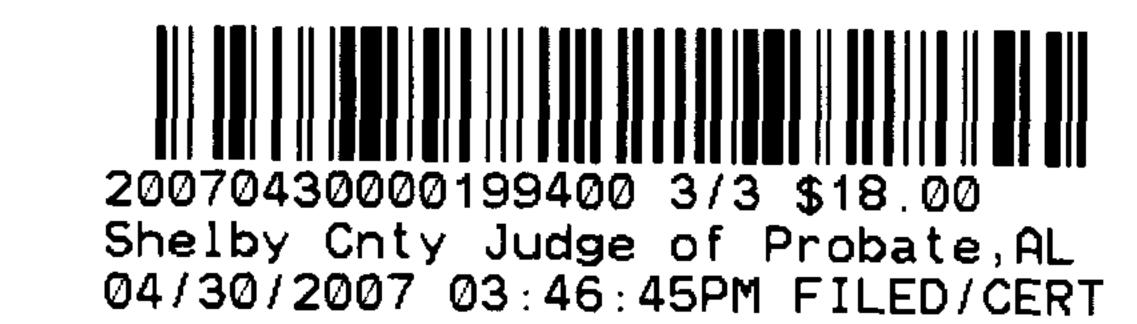
