KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of Three Hundred Sixty-Nine Thousand and 00/100 (\$369,000.00), and other good and valuable consideration, this day in hand paid to the undersigned Grantors, Sean Tinney and Monique Tinney, Husband and Wife, (hereinafter referred to as Grantors), the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantee, Richard A. Limbach, (hereinafter referred to as Grantee), in fee simple, together with every contingent remainder and right of reversion, their heirs and assigns, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

Lot 119, according to the Final Plat of Arbor Hill Phase IV, as recorded in Map Book 35, Page 52, in the Probate Office of Shelby County, Alabama.

SUBJECT TO:

1. Ad valorem taxes due and payable October 1, 2007.


- 2. All restrictions, easements, Rights of parties in possession, encroachments, liens for services, labor, or materials, taxes or special assessments, building lines.
