FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 25th day of February, 2005, Paul D. Naramore and Anita R. Naramore, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as nominee for Michigan Fidelity Acceptance Corp d/b/a Franklin Mortgage Funding, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20050304000104100, said mortgage having subsequently been transferred and assigned to Bank of New York, as trustee for the Certificate Holders of CWABS 2005-06, by instrument recorded in Instrument Number 20060224000090330, in the aforesaid Probate Office; and


