

**ARTICLES OF ORGANIZATION
OF
GREENSLEEVES, L.L.C.**

The undersigned, acting as the organizer of a limited liability company under the Alabama Limited Liability Company Act (the Act), hereby adopt the following Article of Organization for **GREENSLEEVES, L.L.C.** (the Company).

ARTICLE ONE

The name of the Company is **GREENSLEEVES, L.L.C.**

ARTICLE TWO

The Company shall continue in existence until it is dissolved in accordance with the provisions of the operating agreement, or, if there is no operating agreement or no provision in the operating agreement governing the duration of the Company, then in accordance with the Alabama Limited Liability Company Act.
