

Pursuant to the provisions of Section 11-42-21 of the Code of Alabama (1975),

Whereas, the attached written petition requesting that the above-noted property be annexed to the City of Chelsea has been filed with the Chelsea City Clerk; and

Whereas, said petition has been signed by the owner(s) of said property; and

Whereas, said petition contains (as Petition Exhibits A&B) an accurate description of said property together with a map of said property (Exhibit C) showing the relationship of said property to the corporate limits of Chelsea; and

Whereas, said property is contiguous to the corporate limits of Chelsea, or is a part of a group of properties submitted at the same time for annexation, which is zoned AR which together is contiguous to the corporate limits of Chelsea;

Whereas, said territory does not lie within the corporate limits of any other municipality;

Whereas, even though said properties are located in an area where the police jurisdiction of Chelsea and the police jurisdiction of Westover overlap, the said properties are less than equidistance from the respective corporate limits of Chelsea and Westover (i.e. it is closer to the corporate limits of Chelsea than to the corporate limits of Westover).

Therefore, be it ordained that the City Council of the City of Chelsea assents to the said annexation: and

Be it further ordained that the corporate limits of Chelsea be extended and rearranged so as to embrace and include said property, and said property shall become a part of the corporate area of the City of Chelsea upon the date of publication of this ordinance as required by law.

TRACT 3:

Beginning at the NW corner of the NE ¼ of the SE ¼ of Section 32, Township 19 South, Range 1 East, Shelby County, Alabama; thence run South along the West line of said NE ¼ of SE ¼ of said Section 32, a distance of 452.82 feet to the North right of way line of Shelby County Hwy. #450, said point being on a curve to the left, having a central angle of 12 degrees 44 minutes 17 seconds and a radius of 1,050.72 feet; thence run in a Northeasterly direction along the arc of said curve for a distance of 233.60 feet, to a point on a reverse curve to the right, having a central angle of 05 degrees 27 minutes 39 seconds and a radius of 2,030.00 feet; thence run along the arc of said curve a distance of 193.48 feet to a point; thence run due North along a line that runs North and South and is 410 feet East of and parallel to the West line of said ¼ - ¼ Section, and 195 feet, more or less, to the point of beginning; thence continue along said line a distance of 97.5 feet; thence run in a Northwesterly direction a distance of 430 feet, more or less, to the NW corner of said ¼ - ¼ Section; thence run in a Southeasterly direction a distance of 470 feet, more or less, to the point of beginning.
