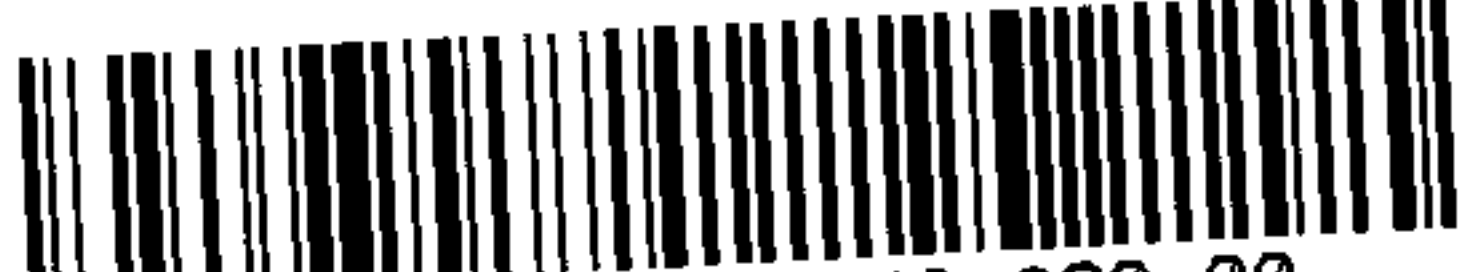

ARTICLES OF ORGANIZATION

OF

KCW VENTURES, LLC

TO THE JUDGE OF PROBATE OF SHELBY COUNTY, ALABAMA:

Pursuant to the provisions of the Alabama Limited Liability Company Act (hereinafter referred to as "the Act"); the undersigned hereby adopts the following Limited Liability Company Articles of Organization:

ARTICLE I NAME

The name of the limited liability company ("Company") is:

KCW VENTURES, LLC

ARTICLE II DURATION

Unless it is dissolved and its affairs wound up as provided in the Operating Agreement or as may be required by the Act, the Company shall have perpetual duration and succession in its name beginning on the date these Articles are filed with the Judge of Probate.

ARTICLE III PURPOSES

The Company has been organized for the following purposes:


(1) To engage in the business of acquiring, owning, developing, improving, operating, leasing, selling and otherwise dealing in and with improved and unimproved real property directly and indirectly.

(2) For any lawful purpose or purposes for which a limited liability company may be organized under the laws of the State of Alabama.

ARTICLE IV INITIAL REGISTERED OFFICE AND INITIAL REGISTERED AGENT
