PROPERTY DESCRIPTION:

A parcel of land lying in the Northeast Quarter of the Southeast Quarter of Section 25, Township 21 South, Range 3 West, Shelby County, Alabama, being more particularly described as follows: Commence at the Northwest corner of the Northeast Quarter of the Southeast Quarter of Section 25, Township 21 South, Range 3 West, Shelby County, Alabama; thence run east along said 1/4-1/4 line for a distance of 271.00 feet to an iron pin found, said point being the point of beginning; thence continue along last course for a distance of 294.82 feet to an iron pin found; thence deflect an angle right of 66 degrees 47 minutes 30 seconds and run a distance of 468.45 feet to an iron pin set, said point lying on the North right of way of Stage Coach Road having a 40.00 right of way; thence deflect an angle right of 75 degrees 00 minutes 29 seconds and run a distance of 187.45 feet along said right of way to an iron pin set, said point being the point of curvature; thence deflect an angle left of 00 degrees 57 minutes 43 seconds and run along said right of way a chord distance of 83.16 feet through a curve with a radius of 2080.64 and a delta of 2 degrees 17 minutes 25 seconds to an iron pin set; thence deflect an angle left to 1 degrees 15 minutes 42 seconds and run along said right of way a distance of 60.24 feet to an iron pin set; thence deflect an angle right of 111 degrees 15 minutes 23 seconds and run a distance of 675.49 feet to the point of beginning.
