#### SECOND AMENDMENT TO

# ARTICLES OF INCORPORATION OF

# ALABASTER CHRIST-CENTERED UNITED APPEAL FUND, INC.

#### KNOW ALL PERSONS BY THESE PRESENTS:

I, the undersigned, Carol Cook-Carter, president of Alabaster Christ-Centered United Appeal Fund, Inc., an Alabama nonprofit corporation ("Corporation"), hereby certify that the following amendments to the articles of incorporation of the Corporation have been duly adopted in accordance with the provisions of section 10-3A-82 *Code of Alabama* (1975), as in effect from time to time, and deliver these articles of amendment to the Probate Judge of Shelby County in accordance with section 10-3A-83 *Code of Alabama* (1975):

- (1) The name of the Corporation is Alabaster Christ-Centered United Appeal Fund, Inc.
  - (2) The articles of incorporation are amended as follows:
    - (a) Section 5 of the Articles of Incorporation is amended and restated as follows:

#### SECTION 5. QUALIFICATIONS OF MEMBERS

To become a member of the Corporation, an organization must (a) be an organization described in Code Section 501(c)(3), (b) must not be a private foundation as defined in Code Section 509, and (c) must be approved by the board of directors. There shall be no membership fee or dues required to become and remain a member of the Corporation. If any member for any reason ceases to be described in clause (a), or (b), that organization shall immediately and automatically cease to be a member and no further payments shall be made to that organization from the Corporation.

(b) Section 10.1 of the Articles of Incorporation is amended and restated as follows:

## SECTION 10.1. Initial Directors

The initial board of directors shall consist of six directors, and successor board of directors shall be composed of not less than three and no more than eleven directors, as from time to time designated in the bylaws. The names and addresses of the persons who are to serve as the initial directors are as follows:

The initial directors shall serve as such for one year and for so long thereafter until their successors are duly elected by the members. Thereafter, the directors shall be appointed in the manner and for the terms provided in the bylaws.

(3) The above amendments were adopted by a consent in writing signed by all members to vote with respect thereto on March 13, 2007.


