WITNESSETH, THAT THE SAID FIRST PARTY, Eckert LLC, for good and valuable Sonsideration and for the sum of Ten and 90/400 dollars, the receipt and sufficiency whereof is hereby acknowledged, does hereby release and quitclaim to the second partities, Edna Mae Eckert and Martha A. Eckert, FOREVER, as JOINT TENANTS with rights of survivorship, their interest in the following described real estate situated in SHELBY COUNTY, ALABAMA TO WIT.
