

**ARTICLES OF INCORPORATION
OF

Pursuant to the provisions of the Alabama Business Corporation Act, the undersigned hereby adopt the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of the corporation is Custom Collegiate Golf Cart Distributors, Inc.

**ARTICLE II
DURATION**

The period of duration is perpetual.

**ARTICLE III
PURPOSES**

The Corporation has been organized for the following purposes:

1. To engage in the business of selling golf carts; and
2. The transaction of any or all lawful business which may be incidental or beneficial to the corporation.

**ARTICLE IV
AUTHORIZED CAPITAL STOCK**

The number of shares which the corporation shall have authority to issue is 1,000.

ARTICLE V

OFFICE & REGISTERED AGENT

The location and street address of the initial registered office shall be 130 Inverness Plaza, Box 232, Birmingham, Shelby County, Alabama 35242, and its registered agent at such address shall be Bobby Hill. Such registered agent accepts the appointment as well as the duties that accompany such appointment.

RESTRICTIONS OF TRANSFER OF STOCK


Each share of the capital stock shall be subject to a condition that the transfer of such stock is restricted in that such stock may not be sold to any person or organization which is not then currently a stockholder in the corporation without first tendering the shares to the corporation by notice addressed to the Board of Directors, and then in turn to the other stockholders of the corporation in proportion to their then existing share ownership interests (after disregarding the shares being offered for sale) at the same price and on the same terms as offered to the proposed purchaser. A copy of the offer to purchase or to sell must be sent to the Board of Directors with the notice.

Each certificate representing shares of the capital stock shall bear a legend stating in substance that the capital stock is subject to this Restriction on Transfer.

The corporation shall not be obligated to transfer on its books or to recognize for voting or any other purpose any stock sale not conforming with this Article.

Any provision, not inconsistent with the law, for the regulation of the internal affairs of the Corporation may be added.



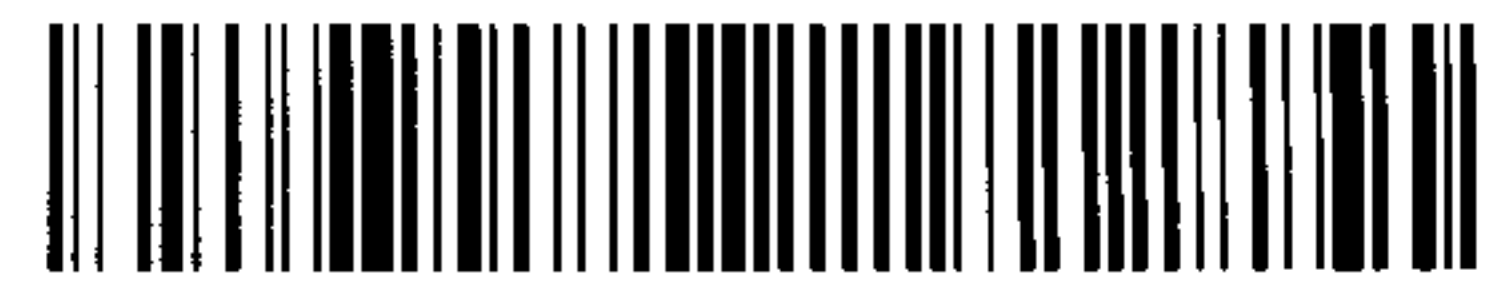
