

MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on October 5, 2005, Lisa White, unmarried, Party of the First Part, executed a certain mortgage to Mortgage Electronic Registration Systems, Inc. acting solely nominee for Accredited Home Lenders, Inc., which said mortgage is recorded in Instrument No. 20051014000537780, in the Office of the Judge of Probate of Shelby County, Alabama. Which said Mortgage was last sold, assigned and transferred to GRP Loan LLC; and

WHEREAS, the highest and best bid obtained for the property described in the aforementioned mortgage was the bid of GRP Loan, LLC in the amount of **ONE HUNDRED TWELVE THOUSAND NINE HUNDRED NINETY-NINE AND 35/100 DOLLARS** (\$112,999.35); which the person conducting the sale on behalf of the mortgagee offered to credit on the indebtedness secured by said mortgage, and said property was thereupon sold to GRP Loan, LLC; and
