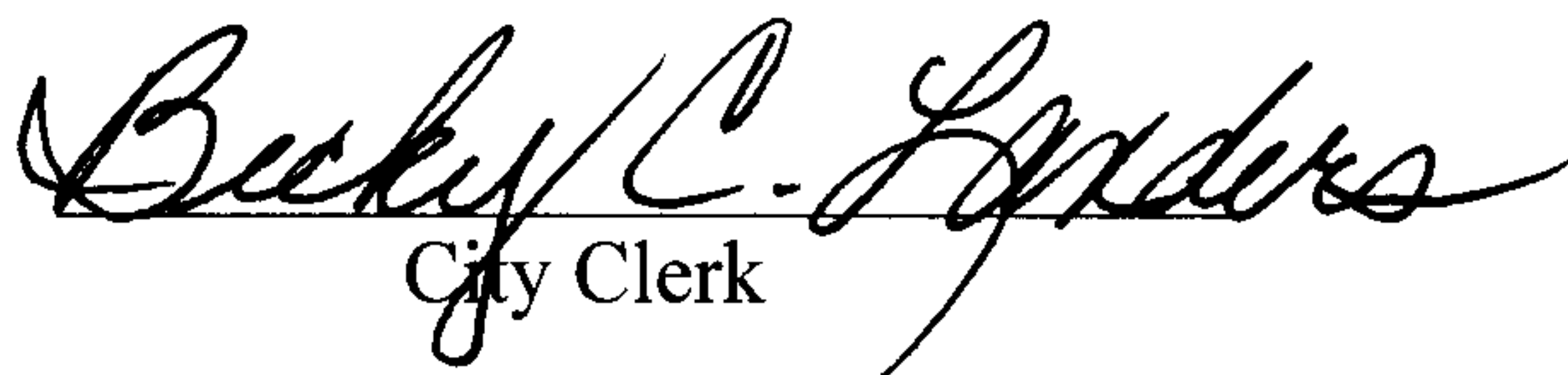
CERTIFICATE OF APPOINTMENT
