I, HAZEL P. BAUCUM, residing in Talladega County, Alabama, being of sound mind and disposing memory and over the age of twenty-one (21) years and with the knowledge of the uncertainty of life, do make, publish and declare this to be my LAST WILL AND TESTAMENT, hereby revoking all other wills and testaments heretofore by me made.

(1) I direct that all of my debts, including the expenses of my last illness and funeral, shall first be paid out of my estate by my Executrix, hereinafter named, as soon as practicable after my death.

(2) I will, give, bequeath, and devise all of my real property, wherever the same may be situated, together with all appurtenances and improvements in connection therewith, to my beloved daughter, GLENDA GERTRUDE BROWN WOOTEN, during the term of her life, with remainder to such of my lineal descendants, per stirpes, as survive my said daughter. It is intended hereby to pass to my beloved daughter, GLENDA GERTRUDE BROWN WOOTEN, a life estate in all real estate to which I die seized and possessed or in which I have an interest at the time of my death, and to pass to my lineal descendants who survive my daughter, per stirpes, the fee simple interest in and to all such real property, to vest in them at the death of my said daughter. It is my intent that my daughter shall have all the rents, profits or other income, including, but not limited to, the proceeds of the sale of any crops, timber, or minerals, cultivated, cut or extracted prior to her death, and I will, give, devise, and bequeath unto my said daughter all such rents, profits, or other income.

(3) I will, give, bequeath, and devise unto my beloved daughter, GLENDA GERTRUDE BROWN WOOTEN, all of my personal property wherever the same may be situated, of whatever nature, kind, character, or description thereof may be, which I own at the time of my death, including but not being limited to, cash in banks, stocks, bonds, mortgages, notes and accounts receivable, insurance payable to my estate, and all of my personal belongings. It is intended hereby to pass to my beloved daughter, GLENDA GERTRUDE BROWN WOOTEN, all of my estate not set forth in Item Two hereof.

(4) In the event my beloved daughter, GLENDA GERTRUDE BROWN WOOTEN, should predecease me, then in that event, I will, give, bequeath and devise unto my lineal descendants, per stirpes, all of my real and personal property wherever the same may be situated, of whatever nature, kind, character or description thereof may be, to which I die seized and possessed or have an interest therein at the time of my death. It is intended hereby that in the event my beloved daughter should predecease me, to pass to my lineal descendants, per stirpes, my entire estate; the same to be theirs fully, finally, and absolute in fee simple forever.

(5) I hereby nominate and appoint my beloved daughter, GLENDA GERTRUDE BROWN WOOTEN, as Executrix of this my Last Will and Testament, and exempt her from making or giving bond or security as such Executrix and exempt her from making or filing any report or accounting to any court in connection with the administration of my estate. In the event my beloved daughter, GLENDA GERTRUDE BROWN WOOTEN, should predecease me, then in that event, I nominate and appoint my grandson, PHILLIP L. WOOTEN, as Executor of this my Last Will and Testament and exempt him from making or giving bond or security as such Executor and exempt him from making or filing any report or accounting to any court in connection with the administration of my estate.
