ARTICLE I
NAME

The name of the limited liability company (the "Company") is:

ARTICLE II
DURATION

The existence of the Company shall be perpetual, or until terminated by agreement of the member or members or by operation of law.

ARTICLE III
PURPOSES

MANAGEMENT



These Articles of Organization are executed by the organizing member as of May 29, 2007.


