FIRST AMENDMENT TO GENERAL (DURABLE) POWER OF ATTORNEY



WHEREAS, my wife, Janet Dean, no longer desires to be named therein to serve as an agent,


NOW THEREFORE, this amendment to said Power of Attorney is executed as follows:
