\$134,500.00 of the purchase price received above was paid from a first purchase money mortgage loan closed simultaneously herewith.

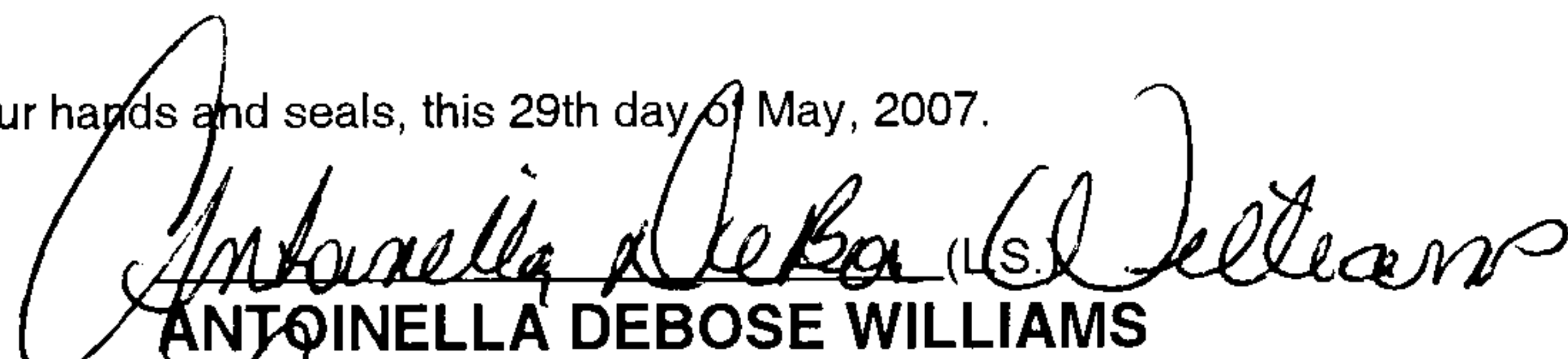
Subject to easements, restrictive covenants and ad valorem taxes of record.

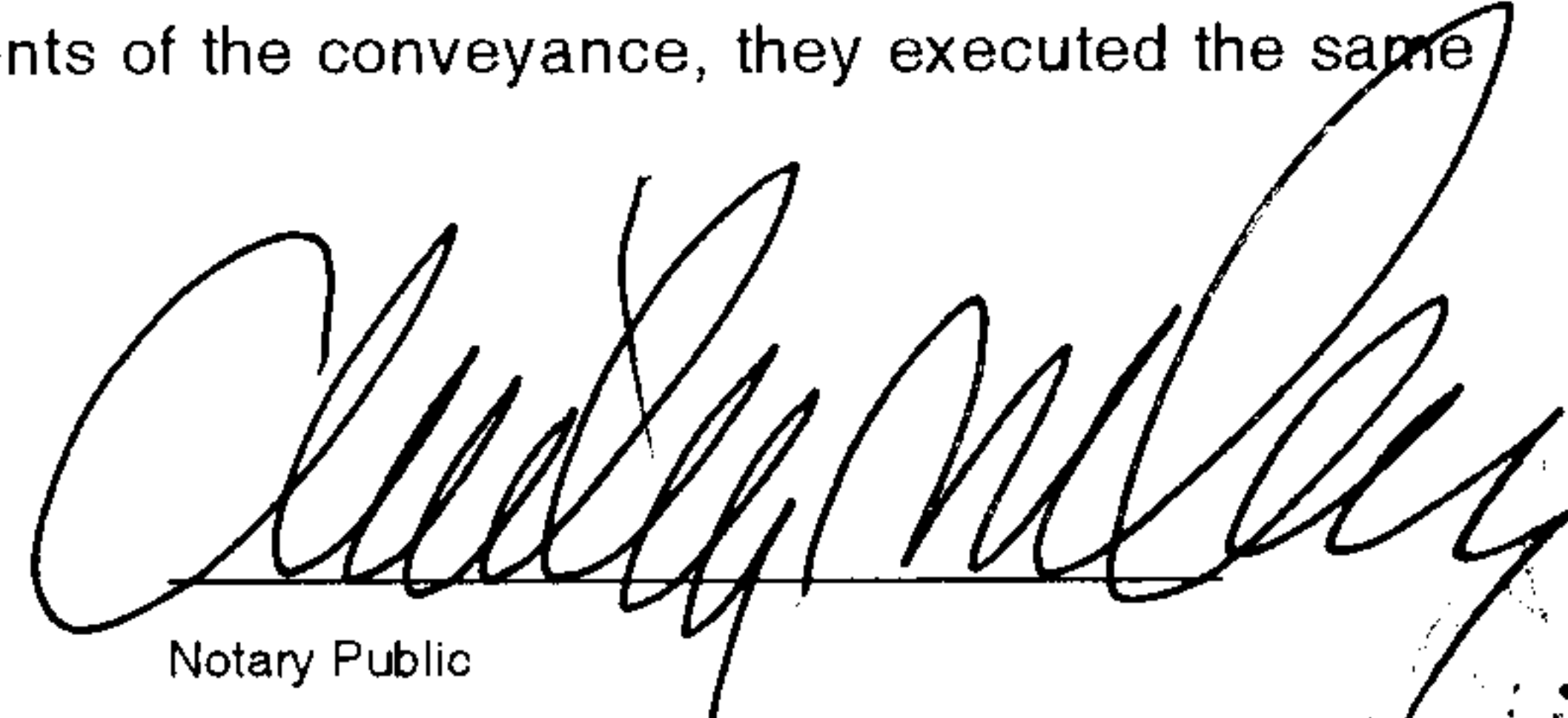
