MANAGEMENT**


The Company shall be managed by the members.


**ARTICLE VIII

These Articles of Organization are executed by the initial members as of June 1, 2007.

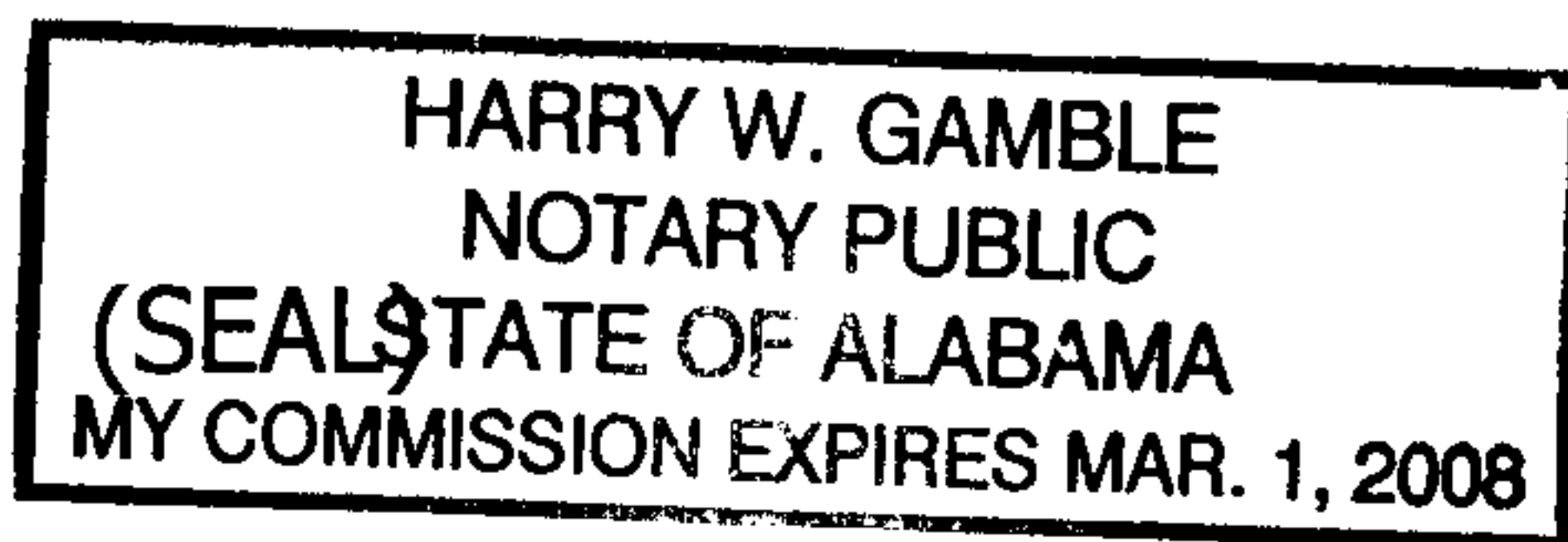
