

ARTICLES OF ORGANIZATION

OF

BEAUMONT VILLAGE, LLC

Pursuant to the provisions of Sections 10-12-1, et seq. of the Code of Alabama (1975), as amended, the undersigned hereby adopts the following Limited Liability Company Articles of Organization:

ARTICLE I NAME

The name of the limited liability company is Beaumont Village, LLC (the "Company").

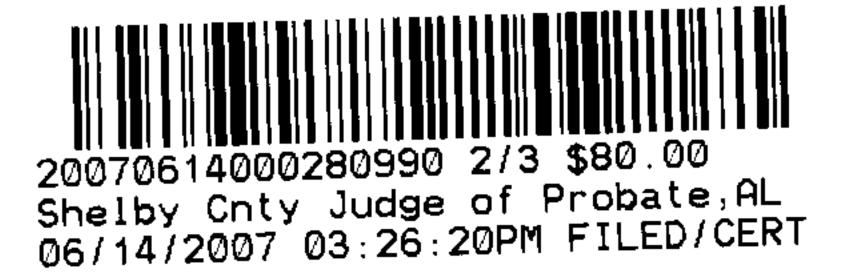
ARTICLE II DURATION

The Company shall have perpetual duration unless it is dissolved and its affairs wound up in accordance with the Alabama Limited Liability Company Act (the "Act") or the Company Operating Agreement.

ARTICLE III PURPOSES

The purposes for which the Company is formed are:

- (a) To purchase, take, receive, or otherwise acquire, own, hold, improve, develop, use and otherwise deal in or with certain real property and improvements, as set forth in the Company's Operating Agreement, and to sell, convey, mortgage, pledge, lease, exchange, transfer and otherwise dispose of such real property, or any interest therein; and to do and perform any and all acts or things necessary, proper or convenient for or incidental to the furtherance or the carrying out of the powers or purposes herein mentioned; and
- (b) To engage in any other lawful act or activity for which limited liability companies may be organized pursuant to the Act, but subject to limitations set forth in the Company's Operating Agreement.



ARTICLE IV REGISTERED OFFICE; REGISTERED AGENT

The location and street address of the initial registered office of the Company shall be 3613 Wingate Lane, Birmingham, Alabama 35242, and its registered agent at such address shall be Michael S. Whitcomb.

Additional Members may be admitted in accordance with the terms of the Operating Agreement of the Company.

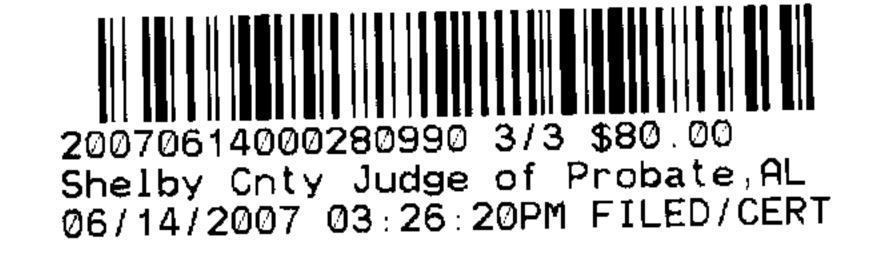
ARTICLE VIII DISSOLUTION BY REASON OF CESSATION OF MEMBERSHIP
