Know All Men by These Presents: That in consideration of FOUR HUNDRED FORTY THOUSAND AND NO/100 DOLLARS (\$440,000.00) to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt of which is acknowledged, I or we, LOWERY HOMES, INC. (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto DAVID E. TRUSS AND CARLA TRUSS (herein referred to as grantees, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 219, according to the survey of Lochinvar at Ballantrae, as recorded in Map Book 32 pages 10 A-B-C in the Probate Office of Shelby County; being situated in Shelby County, Alabama.


Subject to:

(1) Taxes or assessments for the year 2007 and subsequent years not yet due and payable; (2) Mineral and mining rights not owned by the Grantor (3) All easements, restrictions, covenants, and rights of way of record, including but not limited to: (a) Building setback line of 25 feet reserved from Ballantrae Parkway, as shown by plat. (b) Public utility easements as shown by recorded plat, including a 5 foot easement within the building setback line. (c) Declaration of Protective Covenants of said subdivision as set out in Inst. No. 20031001000660220 in said Probate Office. (d) Restrictions, limitations and conditions as set out in Map Book 32 Pages 10 A, B, and C in said Probate Office. (e) Terms and conditions, including release of damages as set out in Deed recorded in Inst. No. 200310160000693380 in Probate Office. (f) Covenant for storm water runoff, as shown in Inst. No. 20031016000693380 in Probate Office. (g) Articles of Incorporation of Ballantrae Residential, Inc. recorded in Inst. No. 2003-66776 in Probate Office.

To Have And To Hold to the said grantees, as joint tenants, with right of survivorship, their heirs and assigns forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy created is severed or terminated during the joint lives of the grantees herein) in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantees, and, if one does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

The grantor covenants and agrees with the grantees that it is seized of an indefeasible estate in fee simple of said property, and that the grantor has the lawful right to sell and convey the same in fee simple; that the grantor is executing this Deed in accordance with the Articles of Incorporation and Bylaws of Lowery Homes, Inc., which have not been modified or amended; that the property is free from encumbrances, and that the grantor and that its successors and assigns shall warrant and defend the same to the grantees, his, her or their heirs and assigns, against the lawful claims and demands of all persons.
