Articles of Incorporation

Pursuant to the provisions of the Alabama Business Corporation Act, the undersigned hereby adopts the following Articles of Incorporation.

Article I

The name of the corporation is F.F. Simulations, Inc.

Article VI

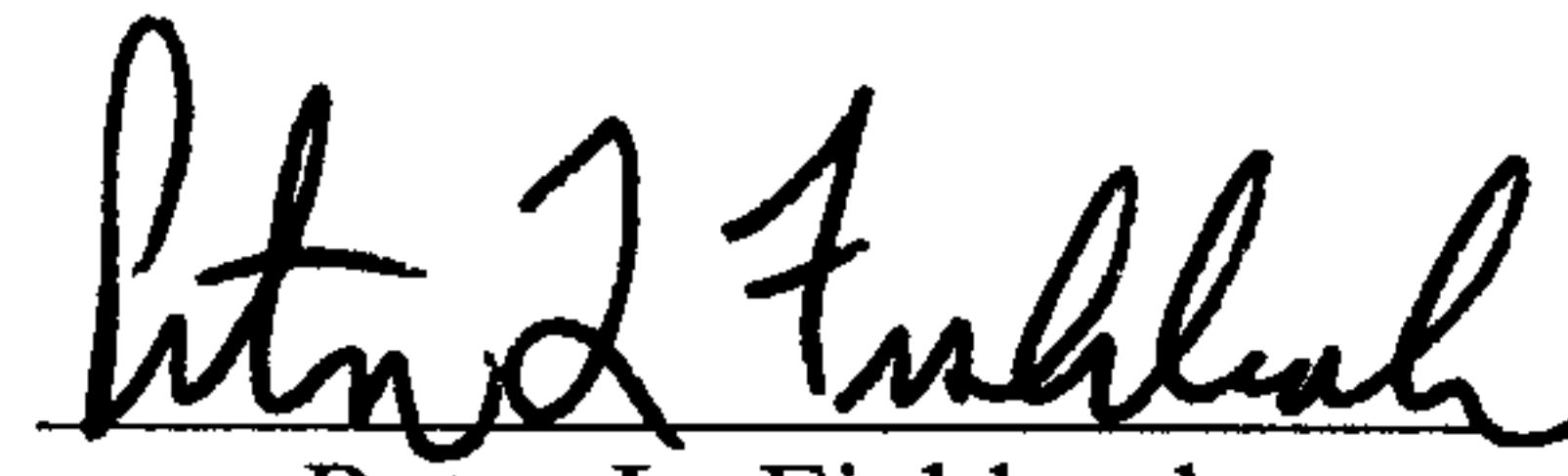
