KNOW ALL PERSONS BY THESE PRESENTS: That WILLIAM P. FURMAN SR, A Single Person, did, on to-wit, December 15th, 2004, execute a mortgage to Union Planters Bank, N.A., now REGIONS BANK, successor by merger with Union Planters Bank, N.A., which mortgage is recorded in Instrument No. 20041222000697620, et seq., in the Office of the Judge of Probate of SHELBY County, Alabama; and


