

GRAPHIC SCALE - FEET

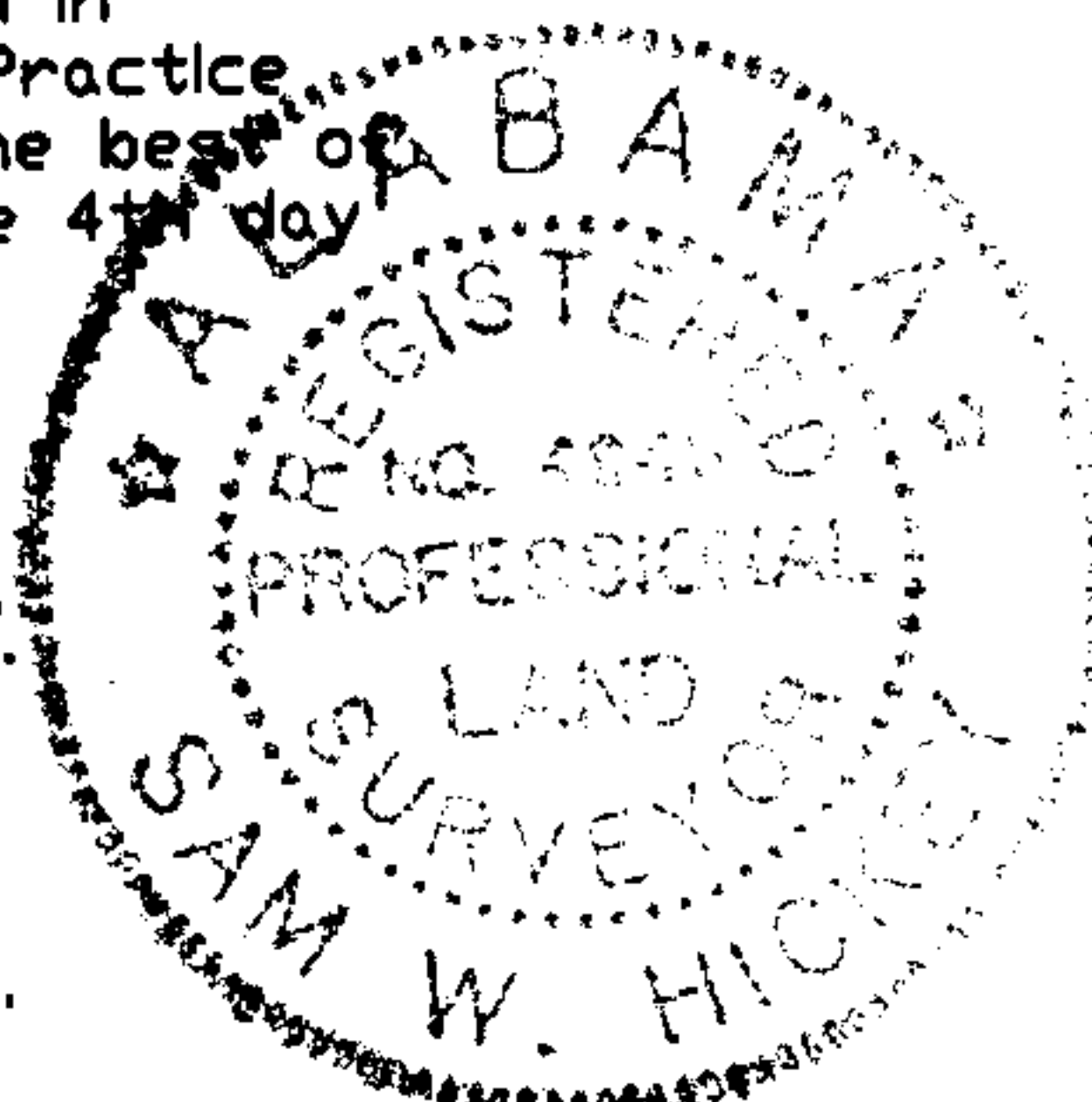
